ACCORDING TO APPROVED SCHEME OF MID CAREER TRAINING PROGRAMME, IPS OFFICERS WHO ARE IN THE 24 TO 26 YEARS OF SERVICE ARE ELIGIBLE TO UNDERGO PHASE V TRAINING. AS PER IPS (PAY) RULES, 2007, NO MEMBER OF THE SERVICE SHALL BE ELIGIBLE FOR DRAWING INCREMENT AFTER COMPLETION OF 28 YEARS OF SERVICE UNLESS HE/SHE COMPLETES THE PHASE V OF THE MANDATORY MID CAREER TRAINING PROGRAMME AS PRESCRIBED BY THE CENTRAL GOVERNMENT. DURATION OF PHASE V MCTP IS FOUR WEEKS HAVING THREE WEEKS AT SVP NPA AND ONE WEEK IN UK, BEING CONDUCTED BY THE INDIAN INSTITUTE OF MANAGEMENT, AHMEDABAD IN COLLABORATION WITH THE LONDON BUSINESS SCHOOL, LONDON, UK AS ITS FOREIGN PARTNER. PHASE V MCTP IS MANDATORY FOR IPS OFFICERS OF 1981 BATCH ONWARDS SINCE THE IPS (PAY) RULES 2007 IS BEING IMPLEMENTED WITH EFFECT FROM 01.01.2009. TOTALLY 286 IPS OFFICERS BELONGING TO 1981, 1982, 1983, 1984, 1985, 1986 AND 1987 BATCHES ARE YET TO COMPLETE PHASE V MCTP. MHA VIDE LETTER NO. 16011/15/2004-IPS.II DATED 27.08.2010 APPROVED ONE TIME RELAXATION TO IPS OFFICERS OF 1981, 1982, 1983 AND 1984 BATCHES AND INTIMATED THAT IPS OFFICERS OF 1981, 1982, 1983 AND 1984 BATCHES MAY BE ALLOWED TO DRAW INCREMENTS AFTER 28 YEARS OF SERVICE, PROVIDED THEY COMPLETE PHASE V BY END OF 2012.

PHASE V MCTP – 2012 OF 4 WEEKS DURATION WILL BE CONDUCTED, WITH FIRST THREE WEEKS AT THE NPA (09.04.2012 TO 27.04.2012) AND LAST ONE WEEK (30.04.2012 TO 05.05.2012) IN UK. IPS OFFICERS OF 1981, 1982, 1983, 1984, 1985, 1986 AND 1987 BATCHES, WHO DID NOT ATTEND EARLIER, ARE ELIGIBLE. HOWEVER PREFERENCE IN SELECTION OF THE NOMINATED OFFICERS WILL BE GIVEN TO IPS OFFICERS OF 1981, 1982, 1983, 1984, 1985 AND 1986 BATCHES.

IF THE NUMBER OF IPS OFFICERS NOMINATED FROM THOSE BATCHES ARE FOUND TO BE LESS THAN THAT OF THE MAXIMUM NUMBER OF SEATS AVAILABLE, THEN THE REMAINING SEATS WILL BE ALLOTTED TO IPS OFFICERS OF 1987 BATCH GIVING PRIORITY TO SENIORITY OF THE NOMINEE. IPS OFFICERS OF 1981, 1982, 1983, 1984, 1985, 1986 AND 1987 BATCHES WHO HAVE LESS THAN 3 YEARS SERVICE ARE NOT ELIGIBLE. REQUEST TO NOMINATE ELIGIBLE IPS OFFICERS OF 1981, 1982, 1983, 1984, 1985, 1986 AND 1987 BATCHES TO THE NPA BY 01.03.2012 FOR THE PHASE V MCTP- 2012 ALONG WITH THE COMPLETE CONTACT ADDRESS WITH TELEPHONE/FAX/E-MAIL ID OF THE OFFICERS. REGARDING IPS OFFICERS OF THE ABOVE SEVEN BATCHES ON DEPUTATION, THE CONCERNED DIRECTORS/DsG/ INCHARGE OF CPOs/CAPFs / DEPARTMENTS MAY PLEASE BE INTIMATED IMMEDIATELY FOR NOMINATING THOSE IPS OFFICERS FROM THEIR END. WE EXPERIENCED DURING THE EARLIER PHASE III, PHASE IV AND PHASE V MCTP CONDUCTED IN 2010 & 2011 THAT MANY NOMINATED IPS OFFICERS HAVE BEEN WITHDRAWN AT THE END CAUSING MUCH INCONVENIENCE TO THE NPA AND THEREBY WE COULD NOT UTILISE THE COMPLETE SEATS IN THE PROGRAMMES. HENCE ALL DSGP OF STATES AND DsG/DIRECTORS OF CPOs/CPMFs ARE REQUESTED THAT ONLY THOSE ELIGIBLE IPS OFFICERS, WHO CAN BE SPARED FOR ONE MONTH TO ATTEND THE PHASE V MCTP WEF 09.04.2012 TO 05.05.2012, MAY PLEASE BE NOMINATED. ONCE NOMINATED SUBSEQUENT WITHDRAWAL OF NOMINATED OFFICERS MAY PLEASE BE AVOIDED. SINCE MAXIMUM NUMBER OF SEATS AVAILABLE IS 140, NOMINATION OF ELIGIBLE IPS OFFICERS OF 1981, 1982, 1983, 1984, 1985 1986 AND 1987 BATCHES (BOTH RR AND SPS OFFICERS) TO ATTEND PHASE V MCTP WEF 09.04.2012 MAY PLEASE BE EXPEDITED. DETAILS OF THE NOMINATED OFFICERS PLEASE BE INTIMATED ON OR BEFORE 01.03.2012 /=
