INTRACTIONS WITH EMINENCE

Management as integral part of police leadership training was richly conceptualized by Prof. Ramnath of IIM-B. The Prof. visited NPA on February 12th, 2009 and in his talk suggested ways to enhance the understanding of visionary leadership by drawing from diverse fields such as Indian mythology.



Hon'ble Union Home Minister Shri P. Chidambaram visited the Academy on February 14th, 2009. Interacting with the Probationers of 2008 batch, Shri P. Chidambaram stated that "Normal policing functions in a country of 120 crores with massive social churning is a complex function. The country today, he stated, is facing a major threat of terrorism which is a global phenomena. Naxalism is another grave challenge to the police forces and the Nation. Third grave challenge posed today is insurgency in the North-East that extends its tentacles across the borders. The policing in 21st century is going to face newer and greater challenges and we need to be very well prepared to meet the challenge ahead of us. The police forces are now willing to work together to meet the increasingly shrinking

world and the Indian Police has to take advantage of this phenomena". The Hon'ble Home Minister also interacted with the faculty of the Academy and discussed the curriculum and the need for updating the inputs to meet the challenges of present day policing.





Dr. David Bayley, a specialist in International Criminal Justice and Policing and a Distinguished Professor, at the School of Criminal Justice, State University of New York at Albany, visited the National Police Academy on February 21st, 2009 to deliver a talk on "Policing Terrorism" to the NPA family and other the distinguished guests from the city.




61st Basic Course Outdoors

BARE HANDS BRAVADO

An Israeli unarmed Combat technique 'KRAV MAGA' has been introduced to the Probationers for the first time. Literally meaning "contact combat" or "close combat", this is an eclectic hand-to-hand combat system developed in Israel. It was derived from street-fighting skills developed by Imi Lichtenfeld, making use of his training as a boxer and wrestler, as a means of defending the Jewish quarter during a period of anti-Semitic activity in Bratislava in the mid- to late 1930's. Unlike most martial arts, Krav Maga is essentially a tactical defense skill. Its philosophy emphasizes threat neutralization, simultaneous defensive and offensive maneuvers, and aggressive endurance in a 'him-or-me' context. The techniques involved generally focus on training combatants in conditions approximating real-life scenarios.



Krav Maga trains combatants for situations where losing would be potentially fatal. Its attack and defense maneuvers aim to neutralize the threat and facilitate rapid and safe escape. These include a variety of fast and fluid crippling attacks to vulnerable body parts through various efficient and often brutal strikes. The improvised use of any available aids is encouraged - maximizing personal safety in a fight is emphasized. Krav Maga training programs involve rapid learning, with offensive and defensive techniques introduced from the first lesson and retzev (pronounced ret-zef and meaning "sequencing") playing an important part in both training and maneuvers. This module was conducted for the Probationers from April 17th to June 24th, 2009.

THE PROBATIONERS GO UNDER WATER

From June 15th-21st, 2009, the Probationers at NPA were exploring the blues and life under water. Scuba Diving was introduced for the first time at NPA. With no firm ground beneath their feet, the faculty and the Probationers both marched under water in arenas unknown. This module included rescue and life saving techniques, exposure to deep water diving and use of kit and equipment of scuba diving.



In-Service Courses



X STRATEGIC MANAGEMENT PROGRAMME (Level-III)

A six-day "Strategic Management Programme" was conducted in the Academy from January 12th-17th, 2009.

The Objectives of the programme were to evolve action plans for implementation on contemporary issues in



Indian Police for improving Police Organizational excellence, understand self and team which govern decision making, understand the environment within which he / she operates and how he / she could be catalyst; and to formulate strategies for development. Shri Milind Kanaskar DD(BC) was the Programme Director. This was a course for the officers of the rank of IGP. 18 officers from the different states & CPOs attended the program.

TRAINING OF TRAINERS COURSE

A one-month "Training of Trainers Course" was conducted in the Academy from January 19th to February 21st, 2009. The objectives of the programme were to describe importance and significance of training in improving police performance and image, enlist characteristics of adult learners; communication principles, select and use training methods, prepare and use training aids, assess training need and develop need based indoor and outdoor course



design for their trainers and develop functional understanding of managing a training organization through visits to various leading institutions during this course. Dr. A.K. Saxena Prof (TM) was the Programme Director. This was a course for the officers of the rank of Dy SP, Addl.SP & SP. 36 officers attended the course.

SYMPOSIUM (30th) Of HEADS OF CENTRAL POLICE TRANING INSTITUTIONS

A two-day "Symposium (30th) of Heads of Central Police Training Institutions" was conducted in the Academy on January 28th-29th, 2009.

The symposium held discussions on exchange of information and sharing of resources available with various police Training Institutions, Creation of National Data Bank of Specialized police Trainers, Field applications of Police Training Networks (POTNET) and Scientific Interventions in Physical Training of Police Officers at Entry level, Special



Weapons and Tactics (SWAT): Upgradation and enhancement of counter terrorism skills with special reference to Urban Centers and the existing Special Task Forces of various States. Shri G H P Raju, DD(A) was the Programme Director. This symposium was organized for the officers of the rank of Dy SP, Addl.SP & SP. 23 officers attended the symposium.



Xth MANAGEMENT DEVELOPMENT PROGRAMME LEVEL-II

A two-week "Management Development Programme Level-II" was conducted in the Academy from February 2nd-13th 2009. The programme aimed at examining and analyzing the internal and external factors affecting the work environment with a view to evolving strategies for improving performance &



providing opportunities for introspection leading to development and growth of the organization. Smt. Anupam Kulshreshtha, AD(IS) was the Programme Director. This was a Programme for the Officers of the rank of DIG. 18 Officers from the different states & CPOs attended the programme.

SEMINAR ON MODERNIZATION OF STATE POLICE FORCES

A 1-day"Semianr on Modernization of State Police Forces" was conducted in the Academy on February 16th, 2009.

The seminar met with the following aims: To gauge the status of the MPF schemes in various states, expectations from the States and CPOs regarding the MPF funds for holistic modernization of their units, sharing of best practices adopted in various states and problems faced in utilization of funds by



various units. The methodology followed in the seminar was presentations on issues of utilization of funds and other related matters by representing States and CPOs. Ms. Satwant Atwal Trivedi AD(P) was the Programme Director. This was a seminar for the Officers of the rank of DIG & above. 28 Officers attended the seminar.

REUNION SEMINAR 1974 BATCH

A 2-day"Reunion Seminar 1974 Batch" was conducted in the Academy from February 19th-20th,2009. The Re-union Seminar theme was MEETING THE MAOIST CHALLENGE—POLICE RESPONSE. The Objectives of the programme



were to utilize the vast experience of retired officers on specific aspects of policing; and to provide an opportunity for officers of the same batch (RR) to meet and exchange their varied experiences. Shri Santosh Macherla, Joint Director (Admn and Senior Courses) was the Programme Director. 26 Officers of the batch attended the seminar.



SCIENCE AND TECHNOLOGY IN POLICE WORK

A one week course on "Science and Technology in Police Work" was conducted in the Academy from March 23rd-28th, 2009. The Objectives of the programme were to appreciate the role of science and technology in police work and administration of justice, List out significant areas of scientific and technological advances relevant



to police work Shri Shirish Jain, AD(A) was the Programme Director. This was a course for the Officers of the rank of SP, DIG & IG. 12 Officers attended the course.

MODULE ON NATIONAL SECURITY

A 4-day Module on "National Security" was conducted in the Academy from March 23rd-26th,2009.

The objective of the Seminar is to increase awareness of the different dimensions and elements that constitute National Security as well as threats to such security, to provide an opportunity for the participants to interact and

exchange ideas on the subject. Smt Satwant Atwal Trivedi, AD(P) was the Programme Director. This was a module for the Officers of the IAS, IFS & IPS in the rank of DM, DFO & SP & above. 22 Officers from the different states attended the module.



WORKSHOP ON PROJECT RECRUITMENT PLAN (2009-2010)

A 1-day workshop on "Project Recruitment Plan" was conducted in the Academy on May 22th, 2009.

The objective of the Seminar was to ascertain the exact number of vacancies in different State Cadres of the Services Vis-à-vis the current authorized strength of each State Cadre, to assess the status of utilization of the



Central Deputation Reserve (CDR) component of the IPS cadre strength, including identifying problems. Shri G.H.P. Raju, DD(A) was the Programme Director. This workshop was organized for the Officers of the rank of SP & above. 35 delegates attended the workshop.



FACULTY DEVELOPMENT PROGRAMME

A 4-day"Faculty Development Programme" was conducted in the Academy from May 25th-28th, 2009.

The faculty of NPA were at the receiving end for a change. For four days they had discussions and talks on Use



counseling skills effectively, evolving strategies for better health management, comprehending and appreciating the concept of impact evaluation of training. The faculty team also visited IIM Bangalore to work on evolving action plans for improving their trainability and NPA training: Shri Anil Kumar Saxena, Prof (TM) was the Programme Director. All the Faculty Members of the Academy attended the programme.

WORKING OF THE SPECIAL TASK FORCES

A 2-day seminar on "Working of the Special Task Forces" was conducted in the Academy from June 8th-9th, 2009.

The objectives of the Seminar were to understand the need to create 'Special Task Forces' for meeting emerging challenges, to identify knowledge, skills & attitudinal requirements of Special Task Force personnel, to share information about the structure and the operational functioning of the Special Task Forces, in particular the tactics adopted in their states, with other participants, to enable the Academy to collate and collect information about the best practices adopted by the STFs in different parts of the country with regard to the structure, tactics, training



methods, welfare policies etc. Shri G.H.P.Raju DD(A) was the Programme Director. This was a seminar for the Officers of the rank of DIG & above. 44 Officers from different states & CPOs attended the seminar.

HIGH LEVEL WORKSHOP ON THE CURRICULUM AND TRAINING DESIGN OF THE BASIC COURSE OF THE INDIAN POLICE SERVICE

A 3-day workshop was conducted in the Academy from June 10th-12th, 2009 with a aim to take forward the training at NPA keeping it in tune with the demands of the field. As an out come of the workshop, it was arrived upon that certain subjects that form the core competency of Basic Training should be focused on. These are leadership, investigation, public order management, handling opinion makers, field-tactics up to company level, generating actionable information (intelligence), combating terrorism, community policing. The group also critically reviewed the



Outdoor Training. Shri Milind Kanaskar, DD(BC) was the Programme Director. This workshop was attended by 29 police officers of the junior, middle & senior level of seniority.

In-Service Courses



ONE WEEK COURSE ON CRIMINAL JUSTICE SYSTEM: INTER-SEGMENT CO-ORDINATION

A One Week Course on "Criminal Justice System" was conducted in the Academy from June 15th-20th,2009. The objectives of the Seminar were to streamline, strengthen and to explore modalities for coordination between various segments of Criminal Justice System, to appreciate the importance of speedy trial in administration of justice in a democratic polity, to understand the dynamics of correctional services in relation with judiciary and

police and to identify innovative ideas of correction, to understand the recent criminal law amendments for better administration of justice. Smt. Satwant Atwal Trivedi AD(P) was the Programme Director. This is a course for District Judges, Superintendents of Jails, Prosecutors and polce officers of the rank of SP & above. 30 Officers attended the course. The Hon'ble Chief Justice of the Andhra Pradesh High Court, Shri Anil Ramesh Dave delivered the valedictory address for the course.



SPECIAL COURSES ON "TACTICS" BEGIN AT THE ACADEMY

On his visit to the Academy on Feb 14th, 2009, the Hon'ble Union Home Minister, Shri P. Chidambaram had categorically desired that the Academy should lay emphasis on specific training inputs to fight terrorism.

Ever on march in it's endeavor to achieve excellence and keep training imparted in tune with times, the senior trainers at NPA put their heads together in consultation with the DGPs of various states and prepared a 5 ½ day module on training in Tactics. This is an intensive training course with 80% hands on outdoors training & 20% indoors' inputs. This is a course for Dy. SP, Addl. SP and SP level officer below the age of 40 years.

These courses aim to make the participants conversant with the conduct of tactical operations in militancy infested area including urban, rural and jungle areas, minor Tactics and basic drills to counter terrorists activities, use of ground and weapons to their tactical advantage. The courses also aim to make the participants aware of latest technologies in terms of weapons, communications equipments, bulletproof jackets / helmets, suitable uniform articles, tentage and ration items to sustain prolonged operations.



As a part of this programme, the delegates from Nepal spent a day at the National Police Academy got acquainted with the working and role of the Indian Police Service and the National Police Academy on January 23th, 2009.

SVP NPA BOARD SUB -COMMITTEE MEETING ON REVIEW OF SYLLABUS

The meeting of SVP NPA Board Sub-Committee on review of syllabus (Basic Training course of IPS Probationers) was held at the Academy on February 26th, 2009. The NPA board had constituted this sub-committee in the last Academy board meeting. Director NPA was nominated as the Chairman and, Director, BPR & D, DGP, Haryana (or his nominee) and Professor (Ms.) Tiplut Nongbri, JNU, Delhi were nominated as members. PRIME MINISTER'S SILVER CUP ESSAY COMPETITION RULES

The Sardar Vallabhbhai Patel National Police Academy will hold an an India Annual Essay Competition for the award of the Prime Minister's Silver Cup. The Prime Minister's Silver Cup shall be awarded for the best essay. The topic for the essay for the year 2009 shall be:

"Image crisis of Indian police: How to effect a lasting makeover?"

The competition shall be held annually and shall be open to all serving police officers/men of India including those serving in Central Police Organizations in India and abroad, provided that an officer who has won the first prize for two successive years shall be debarred from taking part in the Competition for a period of three years at a stretch.

News Letter



RULES

- a. Essays must be submitted in English
- b. Essays must be the original work of the Competitor.
- c. Essays must not be more than 3500 words in length, must be type-written (with double spacing) on only one side of the paper with 1.5 inches margin space on the left hand side and 7 copies must be submitted for the competition.
- d. The pages must be serially numbered and securely stapled or clipped together.
- e. Where a reference is made to any published work, the title and the page number must be quoted in a foot-note.

Essays must be submitted by registered post or recorded delivery. A letter should accompany every essay. This letter must contain details about the competitor's name, rank and the official address of the Force to which he belongs and an endorsement about his age with reference to his service record. The Committee reserves the rights to disqualify any entry, which fails to conform to these rules. If any default comes to the notice of the committee after a prize has been awarded, the committee also reserves the right to take such action against the defaulter as may deem fit. The essays will be submitted to the Director General of Police/Head old Central Police Organization concerned. After due screening at the State/Central Police Organization level, the Director General of Police/Head of the Central Police Organization will forward not more than three essays to the Convener of the Committee of the Competition for final selection of the best essay. The decision of the Committee shall be final. Any essay submitted for the competition and adjudged of sufficient merit and the prize-winning essay may be published by the Director of the Sardar Vallabhbhai Patel National Police Academy and the copy right for such published essays shall vest in the Director. The essays not accepted will not be returned to the competitors. Besides the Silver Cup, which will be returned to the S V P National Police Academy, the Officer adjudged to have written the best essay will be given a prize money of Rs. 10,000/- and a replica of the Silver Cup. The essays considered next in order of merit will be awarded Rs.6,000/- and Rs.4,000/- respectively, along with medals and certificates of distinction. The Cup and the First Prize will be awarded on the occasion of the Annual Passing Out Parade at the Academy. The essays shall be addressed by the Director General of Police/Head of Central Police Organizations to the Director, SVP National Police Academy, Hyderabad-500052 so as to reach on or before October 31th, 2009.

- 2. The length of the article should not generally exceed 5000 words.
- 3. Two copies of the article typed or printed on any type of computer printer in double space with wide margins on good quality paper should be sent. If the articles are typed on computer, a floppy containing the article may also be sent.
- 4. An abstract of the article in 100-200 words and a brief autobiographical note about the author including full name, designation, postal address/e-mail address should also accompany the article.
- 5. One copy of the article may be retained by the author as the original article sent for publication cannot be returned.
- 6. The article should be proof-read and free of corrections.
- 7. Foot-notes and bibliographical references wherever required should be provided along with the article with proper numbering.
- 8. Reference should be cited in the text by using the last name(s) of author(s) and year of publication, using page numbers only in the case of a quote. Multiple citations should be alphabetized. For references with more than two authors, only the first author should be listed followed by et al. If more than one work published in the same year by the same author(s) is citied, they should be designated following the footnotes.
- 9. A submission to SVP National Police Academy Journal is regarded as a commitment to publish. Submission to other journals under review is not acceptable.
- 10. The copy right for articles published is transferred to SVP National Police Academy.
