**2. Eligibility Criteria:**

- Must possess valid licenses/registrations as per local regulations.
- Financial stability and ability to manage operations efficiently.

**3. Scope of Work:**

- To operate and manage a fully functional beauty parlour.

- Ensure customer satisfaction and adherence to ethical practices.


## 6. Terms and Conditions

- The initial contract will be for a period of one year, extendable for two more years on a yearly basis upon mutual agreement.
- Monthly rent will be Rs. 7,000/-, with 10% yearly increase.
- Payment of the electricity bill will be the responsibility of the second party (vendor).
- A security deposit of Rs. 10,000/- will be required.
- Subletting the shop is strictly prohibited.
- The second party can withdraw from the contract before its expiry with 45 days' advance notice.
- In case of violation of any condition, the first party (SVPNPA) reserves the right to terminate the contract without prior notice.
- The beauty parlour facility will be available to both NPA family members and civilians from the surrounding area.
- Service providers will offer a mandatory 20% discount on all services to NPA employees.
- The staff managing the parlour must possess professional beautician course certificates.
