In pursuance of the Rule 13(3) of the D.F.P.Rs, 1978 and in supersession of earlier office orders of the Academy, the following officers are hereby authorized to exercise financial powers with immediate effect, to incur contingent expenditure for various items of expenditure within the limit specified below:

- (ii). The above delegation is subject to the following conditions:
- a) The Faculty Members exercising the financial powers as above should be guided by high standards of financial propriety. Every officer should also enforce financial order and strict economy and see that all relevant financial rules and regulations are observed.
- b) The purchases of stores/equipments are to be made duly following the procedures laid down under GFR-2005. No split purchases are to be resorted to in any circumstances. AO (Admn.) shall ensure that these provisions are not utilized for splitting up purchases.
- c) No faculty member, other than AD(A), DD(A), JD(A) shall exercise financial powers during the last quarter of any financial year. This is prescribed to have control over the progress of expenditure in the last quarter, so that the expenditure can be prioritised and no expenditure over and above the budgetary allocation takes place.
- d) Any file having any financial implication being put up to the Director must be routed through JD (Admn.).
