MEMORANDUM OF COOPERATION ON LAW ENFORCEMENT TRAINING BETWEEN

THE FEDERAL LAW ENFORCEMENT TRAINING CENTERS UNITED STATES OF AMERICA

AND

SARDAR VALLABHBHAI PATEL NATIONAL POLICE ACADEMY GOVERNMENT OF INDIA

This Memorandum of Cooperation (MOC) on law enforcement training is made between the Federal Law Enforcement Training Centers (FLETC), Glynco, Georgia, United States of America and the Sardar Vallabhbhai Patel National Police Academy (SVPNPA), Hyderabad, Telangana, Government of India, herein after referred to individually as "the Participant" and collectively as "the Participants".

Section 1

Objective of MOC

This MOC documents the relationships, roles, and activities of the Participants as outlined below.

Section 2

Areas of Cooperation

a. The Participants intend to conduct regular and ongoing collaboration to explore and share best practices in law enforcement training delivery and to assist each other in law enforcement training development programs. The number and duration of engagements are expected to be mutually determined by the Participants each year, depending upon the availability of faculty staff and financial resources. The visiting Participant for law enforcement training intends to share viewpoints with the resident Participant while comparing and contrasting curricula, practices, and methods of course delivery for such training from the perspective of the visiting Participant.

b. The resident Participant intends to facilitate the participation of faculty and/or students from the visiting Participant in its law enforcement training programs on a space available basis and with full reimbursement of costs for each such visiting attendee, consistent with Section 3.

Section 3

Application and Funding

- a. Unless otherwise arranged for in writing, each Participant intends to bear its own costs in relation to this MOC. This MOC is not an obligation or commitment of funds, nor does it serve as the basis for a transfer of funds. Expenditures in connection with this MOC are subject to the Participants' respective budgetary processes and the availability of appropriated funds as well as applicable laws and regulations.
- b. This MOC is not a legally binding agreement and should not be construed to create any right or benefit, substantive, or procedural, enforceable by law or otherwise by any person against the Participants, or the officers, employees, agents, or other associated personnel of the Participants.

c. Each Participant acknowledges that it intends to provide workers' compensation insurance or its equivalent to cover the costs of any injuries that their respective employees may incur as a result of their participation in the law enforcement training programs.

Either Participant may discontinue this MOC at any time but should endeavor to provide at least one month's written notice before the date of discontinuation.
- b. This MOC may be modified by the mutual written decision of the Participants.
- c. This MOC may be supplemented by additional arrangements to address specific programs or activities conducted by the Participants.

Section 6

Sensitive Information

Unless otherwise decided in writing, information exchanged under this MOC is considered law enforcement sensitive information that is expected to be protected as such within the U.S. Government and the Government of India and is not expected to be disclosed to any third party outside of the U.S. Government or the Government of India, unless required by applicable law, regulation, or policy, or after written permission from the Participant that provided the information. The Participants intend to continue to apply the provisions of this Section to this after discontinuation of the MOC.

Section 7

Any issue or misunderstanding between the Participants arising out of the Memorandum of Cooperation will be clarified amicably through consultation between the Participants.

Section 8

Other Provisions

Nothing in this MOC is intended to conflict with either Participant's respective laws, regulations, policies, or directives.
