Sardar Vallabhbhai Patel National Police Academy, Hyderabad, the premier Police Training Institution of our country, intends to convert the existing STP behind horse stable at Site 'A' of the Academy to E-STP as per details given below:-

9). Terms and Conditions

- a) <u>Documents required to be submitted</u>: The firm must enclose the following documents:
 - i) Copy of firm's registration certificate
 - ii) Delivery / installation term
 - iii) Copy of Pan Card of the firm
 - iv) Copy of at least one previous work order of same nature / Amount of work as proposed in this work.
- b) <u>Site Visit</u>: Interested vendors may visit the site i.e. behind Horse Stable at Site-"A" of the Academy before submitting the quotation after taking prior permission from the Assistant Commandant (Works) of SVP NPA Hyd..
- c) <u>Earnest Money Deposit</u>: EMD of Rs.37,300/- (Rupees thirty seven thousand three hundred only) should be enclosed in the form of demand draft dawn in any commercial bank in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the

prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time

- d) <u>Terms of payment</u> No advance payment or payment against proforma invoice will be made. Payment will be made only after completion of work.
- The work should be completed within 15 days from the date of receipt of work order from the Academy
- f) The bid should be valid for 180 days from the date of opening of bid.
- g) The scope of work as defined above shall be strictly adhered to.
- In case of deviations, the same shall be explicitly indicated in a separate statement
- i) The total cost of work shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of execution
- j) The period of completion of the work shall be indicated in the offer.
- k) Warranty: The work executed shall carry a minimum warranty period of one year from the date of completion of work and handing over of the work.
- SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- m) <u>Security Deposit</u>:- The successful tenderer is required to submit a Security Deposit equal to 5% of the contract value in the form of a FDR/Bank Guarantee which should remain fixed/valid for a period of 3 months beyond the date of completion of all warranty obligations
- n) The security deposit so furnished will be returned only in case no latent defects are noticed/ surfaced in the work carried out and subject to furnishing of clearance certificate by the Works Section of the Academy.
- The tenderer is required to submit his tender along with EMD in the form of a Demand Draft for an amount equal to 2% of the quoted value
- p) Both the EMD and Security Deposit are to be submitted in favour of "The Director, S.V.P National Police Academy, Hyderabad and payable at Hyderabad.
- q) The work once entrusted, shall be completed in the time frame as stipulated in the work order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.

- r) In case of inordinate delay, the Academy reserves every right to cancel the work order, without any liability including forfeiting the EMD/Security deposit submitted, as the case may be.
- s) The bidder will be blacklisted by the Academy in case of (column-n) above being invoked.
- t) Water and electricity charges arising during the period of execution, shall be to the Contractors account
- 10). Parties interested in carrying out the above work and on acceptance of the above terms and conditions, may submit their quotation alongwith EMD in a sealed cover addressed to the undersigned and duly superscribed as "Converting of existing STP behind Horse Stable at Site 'A' of the Academy into E-STP"- Not to be opened before 29 Jan 2016
- 11) The last date for receipt of quotations is 29 Jan 2016 (Friday) by 1700 Hrs.
