2) Terms and Conditions

- The bidders should have at least two years of experience in the field and a) must enclose copy of certificate of their firm's registration with CPWD or any other Govt agencies and vat/Tin/GST certificate along with the quotation.
- Earnest Money Deposit :- EMD of Rs. 4000/- (Rupees Four thousand only) b) should be enclosed in the form of demand draft dawn in any commercial bank in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time
- Terms of payment No advance payment or payment against proforma invoice will be made. Payment will be made only after Supplying of meterial.
- The material should be delivered within 15 days from the date of receipt of d) supply order from the Academy
- The bid should be valid for 180 days from the date of opening of bid. e)
- The entire scope of supply meterial as defined above shall be treated as a single work and no offer in piece meal shall be accepted

- g) In case of deviations, the same shall be explicitly indicated in a separate statement
- h) The total cost of meterial shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of supplying
- i) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- j) The supplying once entrusted, shall be completed in the time frame as stipulated in the supply order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.
