- 1 SVP National Police Academy, Shivrampally, Hyderabad, invites sealed bids under Two-bid system (separate Technical Bid & Financial Bid) supply of Road Roller to National Police Academy.

- 4) Non transferable tender document containing Specifications, Bid Evaluation criteria and Tender Terms & Conditions.
- 5) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of bid / delay in receipt of bid and such bids will be summarily rejected.

Terms and Conditions

- 1. Bidders, in case of dealers, must compulsorily attach authorized Dealership (OEM) certificate from the manufacturer of the quoted equipment, failing which the bidder will be disqualified.
- 2. The rates i.e. unit rate of each item and total amount including all taxes, transportation charges, labour charges and installation charges, if any, are to be quoted explicitly both in words and figures. No figures or words should be overwritten. Overwritten figures or words should be scored out and re-written under full signature of the authorized signatory. Quotations that do not fulfil this condition will not be considered.
- 3. The firm must enclose the attested copy of their firm's Registration, Delivery terms, Delivery period, TIN of the Firm, Pan Card of the firm, Banker details, Income Tax clearance certificate, Service Tax Returns for the last three years, OEM authorization letter, details of company's profile and list of valued customers, if any and copies of earlier supply orders executed in the past three years should accompany along with the quotation. All these documents are to be attached with the Bid without fail.

Earnest Money Deposit of Rs.32,000/- (Thirty two thousand) only in the form of Demand Draft drawn in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily.

- 4. The bidder should have their own full-fledged service centre in Hyderabad with all necessary tool kits and well qualified Engineers and any service call should be responded within 4 working hours without failure during warranty period. Bidders should submit necessary supporting documents in proof of the same.
- 5. Authorisation letter from OEM certifying that the items quoted by the vendor are in production and would be **supported for service for at least 10 years** (No obsolete products should be quoted).
- 6. The Bid containing the specifications viz. Make, Brand and Model and other information leaflets/catalogue of the proposed brand which the bidder intends to deliver and the delivery schedule by the bidder, shall be enclosed with the tender.
- 7. The Bid shall comprise the price component indicating the unit price including all taxes and installation charges, if any. The unit price thereof shall not be overwritten.
 - a) The quoted price <u>shall be exclusive of all the Taxes</u> and taxes should be shown separately as applicable. No excess amount beyond the quoted amount will be considered.
 - b) Quoted prices **should be inclusive of freight** and forwarding charges, handling charges, loading and unloading charges, insurance charges, etc.
 - c) The prices once accepted by the Purchaser shall remain valid till the successful execution of the complete order to the satisfaction of the Purchaser. The Purchaser shall not entertain any increase in the prices during the period. In the event there is a reduction or increase in Government levy/duties during the period of execution of the order, the rates shall be suitably adjusted with effect from the date notifying the said reduction or increase in the Government levy/excise duty. However, the Purchaser is not liable to any claim from the Supplier on account of fresh imposition and/or increase of Excise Duty, Customs Duty, Sales Tax etc. on raw materials and/or components used directly in the manufacture of contracted goods taking place during the pendency of contract.
 - d) Prices shall be quoted in Indian rupees only.
- 8. The Bid / Tender submitted shall necessarily remain valid for 180 days after the date of commercial bid opening. If any bidder withdraws his tender before the said period, SVP NPA shall-without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security submitted along with the bid.

- 9. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time. If the quotation is accepted and the contracted firm fails to undertake the supply contract, their EMD will be forfeited without any further notice.
- 10. The Director, SVP National Police Academy <u>reserves the right to order full or part thereof</u> of the items enclosed or accept/reject any or all the bids without assigning any reason.
- 11. The bidding firm should submit an undertaking along with their bid, that they would adhere strictly to the delivery schedule indicated in this tender document failing which they would be penalised with a penalty **equal to 0.5%** of the supply contract value for every week period's delay. Failure to enclose this undertaking would entail rejection of the submitted offer without any further intimation.
- 12. The Technical Bid along with EMD in the form of demand draft, should be placed in one sealed envelope super scribed 'Technical Bid'. The Financial Bid should be kept in a separate sealed envelope super scribed 'Financial Bid'. Both the envelopes should then be placed in one single sealed envelope super scribed 'TENDER FOR SUPPLY OF ROAD ROLLER TO S V P NATIONAL POLICE ACADEMY, HYDERABAD and should be addressed to the Administrative Officer (Admn.), SVP National Police Academy, Hyderabad. Name of the company / bidder shall not be mentioned on the external cover containing the financial & Technical bids. But the same should be mentioned on the cover of Technical & Financial Bids separately.
- 13. Liability of the work order getting cancelled, if the quality / progress of the work is found to be **not satisfactory** or if there is an **inordinate delay** of more than 4 weeks in completing the supply.
- 14. The bidder will be blacklisted by the Academy in case of (condition-13) above being invoked.
- 15. The sealed tender received after the due date and time will be summarily rejected. The bid should be signed at the bottom of each page of tender form.
- 16. The Director SVP NPA reserves the right to cancel the order without pre-notice, forfeit the security deposit or recover any damages for any breach of contract.
- 17. Notwithstanding any of the conditions and clauses indicated in the Tender form, the Director has the whole and sole right to accept or reject either the lowest or any other valid bid and or **split up the order** for supplying of items to more than one bidder or to cancel the Tender without assigning any reasons thereto.
- 18. <u>Attending Tender Opening</u>: The representative of the tenderer who wishes to attend the tender opening is allowed to do so, subject to presenting authorisation letter from the tenderer.
- 19. <u>Guaranty / Warranty Clause</u> :- 12 month warranty from the date of acceptance of the items by the Academy.

20. Performance Security Clause :-

The successful bidder shall have to deposit a performance security equal to 5% of the contract value of the supply rounded up to next hundred in the form of account payee demand draft / bank guarantee from a nationalized / scheduled commercial bank in favour of the Director, SVP NPA Hyderabad payable at SBH Shivarampally, Hyderabad within 10 days of the placement of supply order for due performance as per the provisions contained in Rule 158 of GFR–2005. Failure on the part of the firm to deposit the performance security within stipulated time, the purchaser reserves the right to cancel the Supply Order. Performance Security submitted by the bidder will remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. No interest will be payable for "Performance Security".

21. **Evaluation of Bids:**

- a) The Tender Committee appointed by the Purchaser will open all Bids on the appointed date, time and venue in the presence of all bidders or their representatives.
- b) During evaluation of the bids, the Purchaser may, at its discretion, ask the Bidder for clarifications of its bid/samples of the offered equipment. The clarification of the bidder shall be in writing.
- c) No bidder shall contact the purchaser on any matter relating to its bid from the time of the bid opening to the time the purchase order is placed. If the Bidder wishes to bring additional information to the notice of the Purchaser it should be done in writing.
- d) Any effort by a bidder to influence the Purchaser in its decisions on bid evaluation, bid comparison or purchase order decision will result in rejection of the bid.
- e) Arithmetical errors in the bids, if any, will be rectified on the following basis:- If there is a discrepancy between words and figures, the lower of the two shall be taken as the bid price. If the bidder does not accept the correction of errors, as aforesaid, its bid will be rejected, and its EMD will stand forfeited.

22 **Eligibility Conditions**

- a) The bidding firm should have the capability to supply the ordered equipment in time as per the schedule indicated in the salient features i.e. the supply/installation shall be completed within 30 days from the date of receipt of purchase order.
- b) Any Government organization/undertaking should not have blacklisted debarred/suspended the bidding firm.
- c) The Vendor should be an entity registered in India.

24 Taxes and duties

- a) Vendor shall be entirely responsible for all taxes, duties, license, fees etc. incurred until delivery of the contracted services to the Academy.
- b) No bid will be considered unless and until all the pages / documents comprising the bid are properly numbered, signed and stamped by the person/s authorized to do so.

25 <u>Demonstration of offered equipment</u>

The bidder should provide demonstration of equipment offered, in case the TPC so desires. Failure to provide samples/offer demonstration shall entail rejection of bid forthwith.

26) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of bid / delay in receipt of bid and such bids will be summarily rejected.
