NOTICE INVITING TENDER

Sub: Purchase of 15 nos. All-in-one Systems of S.V. P National Police Academy under buyback - Reg.

Dear Sir,

1. The S.V.P. National Police Academy, Hyderabad, intends to **Upgrade of 15 Zenith All-in-one Systems** of Configuration-Intel Pentium C2D, 1 GB RAM, 80 GB HD. To new system configuration – intel core i5, 4 GB RAM, 500 GB HDD, 19" Display size with **3 Yrs comprehensive onsite warranty** under buy back scheme.

2. Technical specifications & other terms and conditions of the above are enclosed herewith.

3. As such, if you are interested in supplying upgraded Desktop Systems with desired specifications under buyback scheme as mentioned, you may submit your quotation duly indicating the cost of the equipment including all taxes and installation charges and other conditions such as warranty etc.

4. **Terms and Conditions:**

(a) **Technical bids and Commercial bids shall be in** one sealed envelopes, addressed to ***The Director, S.V.P National Police Academy, Shivrampally, Hyderabad- 500 052.*** The envelopes containing the respective bids should be super-scribed **"Up-gradation of 15 Zenith All-in-one Systems of S.V. P National Police Academy: to be opened by addressee only"**.

(b) Technical bid should include information related to all specifications sought. It should also contain company brochures of all equipments and should be accompanied by relevant technical documents issued by the manufacturer in support of specifications asked for.

(c) Firms should be submitting only required documents in technical bid. Numbering of all the pages of technical bid is necessary. Checklist of all the important documents should also be enclosed in the technical bid.

(d) Tender should be accompanied by a Demand Draft to the Value of **Rs. 10,000/-** towards Earnest Money deposit to the credit of 'THE DIRECTOR, SVP NATIONAL POLICE ACADEMY, Hyderabad. **Tender not accompanied by earnest money will not be considered and will be summarily rejected.**

(e) Delivery/Installation is to be completed within 60 days from the date of Purchase Order failing which, penalty @ 0.5% of the Purchase Order value will be recovered for every week period delay from the final payment. Further in case of inordinate delay of 60 days from the date of Purchase Order, this purchase order stands cancelled without any further notice and you will also be liable to be blacklisted.

(f) After the expiry of the stipulated delivery period, which includes extension period if any, no item shall be accepted by SVP NPA. If the tenderer applies for the extension of the delivery period, the extension can be granted on valid grounds only once and up to a maximum of 30 days.

(g) Payments would be made only after the receipt of all the items ordered in the supply order. In cases, where part supply has been made and the supply order for the remaining items has been cancelled, payment would be made for the supplied items after deducting the penalty, if any

(h) No interest will be allowed on the earnest money or security deposits so remitted and no claim shall be entertained in respect of the same. It may specifically be noted that ordinarily payment will be made only after full supplies are completed as per orders and that no advance payment can be arranged.

(i) If the tenderer fails to supply goods within stipulated delivery period then the supply order will stand cancelled and the security deposit shall be forfeited. In addition, the tenderer may be blacklisted for a definite period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same product(s) will be awarded to the L2 tenderer based on the same documentation & processes.

5. Price bid

- Prices mentioned in purchase order are till the execution of the order by the firm. Increase in price, if any, subsequently shall not be entertained.
- The quantity of order may vary and the Academy has the right to increase or reduce the required quantity.
- **The buyback offered machines should be accepted on as is where is basis and value should be quoted separately in the price bid.**

6. Taxes

- Prices quoted should be Inclusive of all taxes

7. Pre-Tender Qualifications:

- (a) Firm Registration Certificate.
- (b) The Vendor should submit OEM Authorisation letter with Tender Reference Number and due date and should have OEM support in Hyderabad / Secunderabad.
- (c) Sales Tax clearance / VAT Registration.
- (d) Details of previous experience / supply.

- (e) Income Tax Returns and details of last three years turn over.
- (f) The bidder should have a minimum turnover of Rs. 1 Crore in the last financial year.
- (g) Banker details.

8. Further on accepting your offer and on placing purchase order, you will submit Security Deposit of the amount about 5% of the purchase order value, in the form of a Bank Guarantee/ FDR drawn in favour of 'The Director, S.V.P National Police Academy, Hyderabad' within 15 days of receiving the purchase order.

9. The Academy reserves the right to accept or reject the tenders without assigning any reason thereof.

10. Your quotation along with the requisite EMD, technical brochures/information leaflets shall be sent in a sealed cover addressed to the undersigned and duly superscribed as **"QUOTATION FOR UP-GRADATION OF ALL-IN-ONE SYSTEMS UNDER BUYBACK OF S.V. P NATIONAL POLICE ACADEMY OF S.V.P. NATIONAL POLICE ACADEMY – NOT TO BE OPENED BEFORE 10-03-2016 ."**
