**NOTICE INVITING TENDER**

**Sub: Supply of IP & PoE based Digital Clocks to S.V. P National Police Academy-Reg.**

Dear Sir,

The S.V.P. National Police Academy, Hyderabad, intends to purchase **IP & PoE based Digital Clocks to S.V. P National Police Academy with 1 Year onsite warranty** for Computer section of the Academy.

2. The Academy would like to purchase 30 (Thirty) Nos of IP & PoE based Digital Clocks along with network cabling and PoE adaptors where ever required, which to be installed in various buildings of the Academy. The specifications of the Digital Clock are as follows. The vendor should study the site before submitting the tender bid for obtaining the network accessories requirements of each location.

1. Type of Clock	PoE Digital clock
2. Time Format	12/24 Hour Format selectable
3. Display	LED Red Colour seven segment display with long Distance visibility
4. Display Size	4 inch ( Hour & Minute)
5. Display Face	Single face display
6. Visibility	Up to. 25 to 30 meters
7. Communication Port	TCPIP Ethernet port
8. Adjustment Control	Provision for time setting switches.
9. Power Supply	Only Through PoE
10. Temperature Range	0 to 60 degree or better
11. Mounting	Wall mount.
12. Enclosure	Metallic duly powder coated
13. Size for HH/MM	460mm X 185mm X 60 mm or better
14. Software	Clock should work with Existing software loaded on server

3. As such, if you are interested in supplying the above product of desired features, you may submit your quotation duly indicating the cost of the equipment including all taxes and installation charges and other conditions such as warranty etc.

4. **Terms and Conditions:**

(a) **Technical bids and Commercial bids shall be in** one sealed envelopes, addressed to ***The Director, S.V.P National Police Academy, Shivrampally, Hyderabad- 500 052.*** The envelopes containing the respective bids should be super-scribed **“Supply of IP & PoE based Digital Clocks to S.V. P National Police Academy: to be opened by addressee only”**.

(b) Technical bid should include information related to all specifications sought. It should also contain company brochures of all equipments and should be accompanied by relevant technical documents issued by the manufacturer in support of specifications asked for.

(c) Firms should be submitting only required documents in technical bid. Numbering of all the pages of technical bid is necessary. Checklist of all the important documents should also be enclosed in the technical bid.

(d) Tender should be accompanied by a Demand Draft to the Value of **Rs.12,000/-** towards Earnest Money deposit to the credit of 'THE DIRECTOR, SVP NATIONAL POLICE ACADEMY, Hyderabad. **Tender not accompanied by earnest money will not be considered and will be summarily rejected.**

(e) Delivery/Installation is to be completed within 60 days from the date of Purchase Order failing which, penalty @ 0.5% of the Purchase Order value will be recovered for every week period delay from the final payment. Further in case of inordinate delay of 90 days from the date of Purchase Order, this purchase order stands cancelled without any further notice and you will also be liable to be blacklisted.

(f) After the expiry of the stipulated delivery period, which includes extension period if any, no item shall be accepted by SVP NPA. If the tenderer applies for the extension of the delivery period, the extension can be granted on valid grounds only once and up to a maximum of 30 days.

(g) Payments would be made only after the receipt of all the items ordered in the supply order. In cases, where part supply has been made and the supply order for the remaining items has been cancelled, payment would be made for the supplied items after deducting the penalty, if any

(h) No interest will be allowed on the earnest money or security deposits so remitted and no claim shall be entertained in respect of the same. It may specifically be noted that ordinarily payment will be made only after full supplies are completed as per orders and that no advance payment can be arranged.

(i) If the tenderer fails to supply goods within stipulated delivery period then the supply order will stand cancelled and the security deposit shall be

forfeited. In addition, the tenderer may be blacklisted for a definite period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same product(s) will be awarded to the L2 tenderer based on the same documentation & processes.

**5. Price bid**

- Prices mentioned in purchase order are till the execution of the order by the firm. Increase in price, if any, subsequently shall not be entertained.
- The quantity of order may vary and the Academy has the right to increase or reduce the required quantity.

**6. Taxes**

- Prices quoted should be Inclusive of all taxes

**7. Pre-Tender Qualifications:**

- (a) Firm Registration Certificate.
- (b) Sales Tax clearance / VAT Registration.
- (c) Details of previous experience / supply
- (d) Banker details.

8. Further on accepting your offer and on placing purchase order, you will submit Security Deposit of the amount about 5% of the purchase order value, in the form of a Bank Guarantee/ FDR drawn in favour of '**The Director, S.V.P National Police Academy, Hyderabad**' within 15 days of receiving the purchase order.

9. The Academy reserves the right to accept or reject the tenders without assigning any reason thereof.

10. Your quotation along with the requisite EMD, technical brochures/information leaflets shall be sent in a sealed cover addressed to the undersigned and duly superscribed as "**QUOTATION FOR Supply of IP & PoE based Digital Clocks to S.V. P National Police Academy – NOT TO BE OPENED BEFORE 26-02-2016.**"

11. The last date for receipt of quotations is **25.02.2016 (Thursday) by 1700 Hrs.**

12. **Right to Cancel the Order :** The Director, SVP NPA reserves the right to cancel the purchase order without any financial repercussion on either side and without seeking the consent of the supplier at any stage of purchase process. No further correspondence in this matter will be entertained.
