10. **Terms and Conditions.**
 - (a) Tender should be accompanied by a Demand Draft for Rs.6,000/-, Earnest Money Deposit drawn in favour of 'THE DIRECTOR, S.V.P. NATIONAL POLICE ACADEMY, HYDERABAD'. Tender not accompanied by prescribed EMD, will not be considered and will be summarily rejected.
 - (b) The tenderer shall be responsible for the proper packing of goods so as to avoid damages under normal conditions of transport by rail, road or air and for delivery of the material in good conditions to the consignee at destination. In the event of any loss, damage, breakage, leakage or any shortage tenderer shall be liable to make good such loss or shortage.
 - (c) Delivery/Installation is to be completed within 60 days from the date of Work Order failing which, penalty @ 0.5% of the Work Order value will be recovered for every week period delay from the final payment. Further in case of in ordinate delay of 75 days from the date of Work Order, this purchase order stands cancelled without any further notice and you will also be liable to be blacklisted.
 - (d) The date of placing the order shall be the date of dispatch of order or the delivery there of to the tenderer, when such order is being delivered through some person.
 - (e) If the tenderer fails to supply goods within stipulated delivery period then the work order will stand cancelled and the security deposit shall be forfeited. In addition, the tenderer may be blacklisted for are in item period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same product(s) will be awarded to the L2 tenderer based on the same documentation & processes.
 - (f) After the expiry of the stipulated delivery period, which includes extension period if any, no item shall be accepted by SVPNPA. If the tendredrer applies for the extension of the delivery period, the extension can be granted on valid grounds only once and upto a maximum of 30 days.

(g) Payments would be made only after the receipt of all the items ordered in the purchase order. In cases, where party supply has been made and the supply order for the remaining items has been cancelled, payment would be made for the supplied items after deducting the penalty, if any.

NATIONAL POLICE ACADEMY, HYDERABAD' within 15 days from the date of Work Order for an amount equal to 5% of the contract value of the supply rounded upto next hundred, which should remain valid/ fixed for a period 2 months beyond the date of completion of warranty.

Your quotation alongwith the requisite EMD, technical brochures/ information leaflets shall be sent in a sealed cover addressed to the undersigned and duly super-scribed as '**QUOTATION FOR LAYING NETWORK CABLES IN OCTAGON OF S.V.P. NATIONAL POLICE ACADEMY, HYDERABAD – NOT TO BE OPENED BEFORE 16-03-2016.**
