- SVP National Police Academy, Shivrampally, Hyderabad, invites sealed bids for repair to coursed rubble masonry of open well inner walls at kolkata garden by filling the CR joints with cement mortar & pointing work and desalting of well at Site-B of Sardar Vallabhbhai Patel, National Police Academy as per the details given below:-

National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time.

- 3) Tender Documents-Tenders are governed by Tender documents
- A) Non transferable tender containing Specifications, Bid Evaluation criteria and Tender Terms & Conditions can be purchased on written request accompanied with payment of Tender Fee through DD drawn in favour of "The Director,, SVP National Police Academy, Hyderabad. Tenderers may also download the tender enquiry documents from the website <a href="www.svpnpa.gov.in">www.svpnpa.gov.in</a> and submit their tender by utilizing the downloaded document, along with the required non-refundable fee as mentioned above.

5) Description of work Providing and laying in position cement concrete of specified grade a) excluding the cost of centering and shuttering - All work up to plinth level: 1:1 1/2:3 (1 cement : 1 1/2 coarse sand : 3 graded stone aggregate 20mm nominal size). b) Reinforced cement concrete work in walls (any thickness), including attached pilasters, buttresses, plinth and string courses, fillets, columns, pillars, piers, abutments, posts and struts etc. up to floor five level excluding cost of centering, shuttering, finishing and reinforcement: 1:1.5:3 (1 cement : 1.5 coarse sand : 3 graded stone aggregate 20mm nominal size) Reinforcement for R.C.C. work including straightening, cutting, bending, c) placing in position and binding all complete. Up to plinth level Thermo-Mechanically Treated bars. Random rubble masonry with hard stone in foundation and plinth d) including levelling up with cement concrete 1:6:12 (1 cement : 6 coarse sand: 12 graded stone aggregate 20mm nominal size) at plinth level with: Cement mortar 1:6 (1 cement : 6 coarse sand) Pointing on stone work with cement mortar 1:3 (1 cement : 3 fine sand) : Raised and cut pointing Filling the Coursed Rubble stone masonry joints of open well inner walls f) with cement mortar 1:3 (1cement : 3 fine Sand) & Pointing with 1:3 cement mortar (1cement: 3 fine Sand) and finishing the same neatly. Desalting of the existing open well by removing existing earth, mud and g) slushy water by bailing out, and removing the earth etc by using mechanical and manual means etc complete to have the fresh water in the well.

#### 6). Terms and Conditions

- a) The bidders should have at least five years of experience in the field and must enclose copy of their firm's registration certificate and copies of earlier work order of same nature along with the quotation.
- b) <u>Terms of payment</u> No advance payment or payment against proforma invoice will be made. Payment will be made only after completion of work.
- c) The scope of work as defined above shall be strictly adhered to.
- d) In case of deviations, the same shall be explicitly indicated in a separate statement
- e) The total cost of work shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of execution
- f) The period of completion of the work shall be indicated in the offer.
- g) The work executed shall carry a minimum warranty period of one year from the date of completion of work and handing over of the work.
- h) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- i) The successful tenderer is required to submit a Security Deposit equal to 5% of the contract value in the form of a FDR/Bank Guarantee which should remain fixed/valid for a period of 3 months beyond the date of completion of all warranty obligations
- j) The security deposit so furnished will be returned only in case no latent defects are noticed/ surfaced in the work carried out and subject to furnishing of clearance certificate by the Works Section of the Academy.
- k) Both the EMD and Security Deposit are to be submitted in favour of "The Director, S.V.P National Police Academy, Hyderabad and payable at Hyderabad.
- The work once entrusted, shall be completed in the time frame as stipulated in the work order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.
- m) In case of inordinate delay, the Academy reserves every right to cancel the work order, without any liability including forfeiting the EMD/Security deposit submitted, as the case may be.
- n) The bidder will be blacklisted by the Academy in case of (column-n) above being invoked.
- Water and electricity charges arising during the period of execution, shall be to the Contractors account
- p) <u>Site Visit</u>: Interested vendors may visit the site before submitting the quotation after taking prior permission from the Assistant Commandant (Works) of SVP NPA Hyd..
- q) Warranty The work executed shall carry a minimum warranty period of 01 year from the date of completion and handing over of the work.

- Performance security: The successful bidder shall have to deposit a performance security of 5% of the contract value of the supply / work order rounded up to next hundred in the form of account payee demand draft / bank guarantee from a nationalized / scheduled commercial bank in favour of the Director, SVP NPA Hyderabad payable at SBH Shivrampally, Hyderabad within 15 days of the placement of supply order for due performance as per the provisions contained in GFR 158. Failure on the part of the firm to deposit the performance security within stipulated time the purchaser reserves the right to cancel the Supply Order. Performance Security submitted by the bidder will remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. No interest will be payable for "Performance Security."
