As such, if you are interested in supplying the above mentioned items with desired features, you may submit your quotation duly indicating the cost of the above items including all materials, manufacture, transportation to site, assembling at site including loading, unloading and assembling, including VAT taxes and excise duties etc, complete for finished item of work. The item shall carry a warranty period of 03 years.

9. Terms and Conditions.

- (a) Tender should be accompanied by a Demand Draft for Rs.4,000/-, Earnest Money Deposit drawn in favour of 'THE DIRECTOR, S.V.P. NATIONAL POLICE ACADEMY, HYDERABAD'. Tender not accompanied by prescribed EMD, will not be considered and will be summarily rejected.
- (b) The tenderer shall be responsible for the proper packing of items so as to avoid damages under normal conditions of transport by rail, road or air and for delivery of the material in good conditions to the consignee at destination. In the event of any loss, damage, breakage, leakage or any shortage tenderer shall be liable to make good such loss or shortage.
- (c) Delivery/Installation/assembling is to be completed within 30 days from the date of Supply Order failing which, penalty @ 0.5% of the Supply Order value will be recovered for every week period delay from the final payment. Further in case of in ordinate delay of 45 days from the date of Supply Order, this supply order stands cancelled without any further notice and you will also be liable to be blacklisted.
- (d) The date of placing the order shall be the date of dispatch of order or the delivery there of to the tenderer, when such order is being delivered through some person.
- (e) If the tenderer fails to supply items within stipulated delivery period then the supply order will stand cancelled and the security deposit shall be forfeited. In addition, the tenderer may be blacklisted for a specified period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same product(s) will be awarded to the L2 tenderer based on the same documentation & processes.
- (f) After the expiry of the stipulated delivery period, which includes extension period if any, no item shall be accepted by SVPNPA. If the tendedrer applies for the extension of the delivery period, the extension can be granted on valid grounds only once and upto a maximum of 30 days.
- (g) Payments would be made only after the receipt of all the items ordered in the work order. In cases, where part supply has been made and the work order for the remaining items has been cancelled, payment would be made for the supplied items after deducting the penalty, if any.

- (h) <u>SAMPLE</u> The Tender Processing Committee of the Academy may require the bidders to provide physical samples to be seen during the opening of bid and to test quality of goods. Bidder is self responsible on his own expenditure for showing the sample before TPC during opening of bid. Failure to produce sample will entail rejection of the said bidder forthwith.

SPECIFICATION OF TWO TIER IRON COTS

- Supply, delivery and assembling at site, Two tier Cot of dimensions 1980mm X 850mm X 1600mm, with overall dimensions/cross sections of each component as shown in the figure attached. Joints shall be interlocked and welded to render a flawless appearance. The 4 legs outer frame shall made up with 40x40 CR square tube 1.6 mm thickness, with horizontal support of dia. 31.7 mm, 1.6 mm thick CR tube and vertical bracings of 19 mm dia, 1.2 mm wall thick at 150 mm intervals. The tops of the cot made with CR sheet of 1.22 mm thick, bed bottom four sides bending 50 X 30 mm and closing internally with C channel 50 X 30 mm, CR sheet 1.22 thickness. Inside two 2 Nos. reinforced with 2 formed length wise channels size 15 x 50 x 50 x 50 x 15 mm CR sheet of 1 mm thickness, flanged ark welded inside the length wise with 5 inches gap.
- O2 Corner Brackets inside 8 Nos welded and outside corner brackets 8 Nos fitted with Nut bolt System (3 mm thickness 125 mm length wise). The ladder steps CR pipe 19 mm 2 mm thickness shall be fixed with 4" steps from the Vertical member of frame. The lower bed height 370 mm and two side head and top bow between top bottom to leg height 200 mm. The top of the pipe closed with MS square watcher clearance between the two beds shall be 940 mm. The hand rail of top tier shall be fixed inside of the cot holes. On the two sides of the central support frame CR tube 25.4 mm 1.22 mm thickness.
- The safety grills rails shall be sloping on one end at either side of the top tier as shown in the figure. Leg bottom to be fixed with PVC bush. Top of the legs shall be closed with metal watchers. All the CR sheet and pipes section are to be pretreated by phospoting treatment (8-stage treatment) and are to be epoxy powder coated 50-60 microns thickness grey shade as per IS: 101
- 04 The minimum weight of the cot shall not be less than 80 Kgs.
- The total cost of unit shall include cost of all materials, manufacture, transportation to site, assembling at site including loading, unloading and assembling including all VAT taxes and excise duties etc., complete for finished item of work. The item shall carry a warranty period of 3 years.

SPECIFICATIONS OF SINGLE COT (STEEL)

- 1. Steel cot (Single Cot) of following specifications. The Cot of bed should be 1980 mm (L) x 850 mm (W) x 460 mm (H).
- 2. The sheet should be made of CR top with guage (1.22 mm) thick CR sheet should be crimped on four sides to a depth of 35 mm so as to accommodate welding with M.S fiat of size 35x5 mm all round the inner edge of the crimp of the sheet. The top of the bottom welded with 2 Nos. reinforced with two formed channels to size 75 mm width and 35 x 15 mm of 1 mm thickness flanges are welded inside the length wise.
- 3. Legs frame CR tube 25 mm round 1.6 guage (thickness) the headbow height should be made of 700 height and legbow 600 mm height. One horizontal and two vertical CR tube 19.5 mm 1.22 mm guage thickness epoxy polyester powder coating plain mat gray only DFT (Dry Film Thickness) of 45 microns as per 19101.
- 4. The total cost of unit shall include cost of all materials manufacture, transportation to site, assembling at site including loading, unloading and assembling including different floor levels of the building including loading, unloading and assembling charges at different floor levels of the building, including VAT and all other taxes TS VAT and AP CST etc. complete for finished item of work.
- 5. The item shall carry a warranty period of 3 years (36 months) from the date of supply.
