#### **NOTICE INVITING e-TENDERS**

Sub: Short-notice Open Tender Enquiry for undertaking Horticulture and Beautification Works at S.V.P. National Police Academy – Reg.

Sir,

Due to the recent heavy rains in the state of Telangana, the flora got badly destroyed, presenting a shabby look inside the campus. There is an urgent need to undertake horticultural works to spruce up the Academy campus, which will be shortly hosting the DGsP/IGsP conference to be attended by the Hon'ble Prime Minister of India, Union Home Minister, both Ministers of State for Home and various other Dignitaries. The SVP National Police Academy, Shivrampally, Hyderabad, therefore invites short-notice **e-bids** under two-bid system from reputed and experienced firms interested in undertaking **Horticulture and Beautification Works** at Site-B of its campus.

2. The salient features of the tender enquiry are as follows:

- 4) Interested Agencies/Firms dealing with undertaking of Horticulture and Landscaping works can download the tender document from Central Public Procurement Portal (https://eprocure.gov.in) and bid should be submitted through the same website. Bids submitted other than on CPP Portal will not be accepted. The eligible bidders should have the digital signature (DSC) issued by any agency authorised by Controller of Certifying Authorities, Govt. of India.
- 5) Bidders can access and download the tender documents from CPP Portal and can fill them with all relevant information and submit the completed tender document online on the website: http://www.eprocure.gov.in. The downloading of tender documents shall be carried out strictly as provided on the website. No editing, addition, deletion of matter shall be permitted. If such action is observed at any stage, such tenders are liable for outright rejection.
- Tender shall be submitted online only at CPPP website. Bidders are advised to refer the Bidders manual kit for e-submission of the bids online through the Central Public procurement portal available at the website: http://www.eprocure.gov.in. Aspiring Bidders who have not enrolled/ registered in e-procurement should enroll/register before participating through the website https://eprocure.gov.in. The portal enrolment is free of cost.
- All the documents as per tender requirement should be uploaded online and further, no documents other than hard copies of Landscape Design concept & Virtual presentation will be accepted offline. Also the hard copy of Demand Draft towards Earnest money deposit should be sent to S.V.P. National Police Academy so as to reach before the due date & time of closing of tender enquiry. Bidders who are not submitting any of the required documents online will summarily be rejected. Firms registered with NSIC/DGS&D who are exempted from furnishing EMD shall attach attested copy of the requisite certificate along with their bid without fail.
- The details of the Tender document and scanned copy of EMD should be filled and uploaded online. Earnest Money Deposit (EMD) for Rs.85,000/- (Rupees Eighty Five Thousand only) should be deposited in form of Demand draft Drawn on any nationalized bank in favour of The Director, SVP National Police Academy, Hyderabad. Bids without EMD will not be considered. Tender Reference Number or details should be mentioned on the backside of the original Demand Draft and the same should be sent to A.O.(Admn.),SVP National Police Academy, Shivarampally, Hyderabad-500052 so as to reach before the due date & time of closing of tender enquiry.

B. The scope of work to be undertaken by the Bidder is indicated in **Appendix-A** and the salient terms and conditions of this Tender Enquiry, are as follows:

#### **Terms and Conditions**

- 1. The TIA (Tender inviting authority) will not be responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders at the eleventh hour. For any quires regarding e-tendering process, the bidders are requested to contact over phone: 1-800-233-7315 or send a mail over to 'cppp-nic@nic.in'.
- 2. The bidder should have a field experience of more than 15 years in undertaking Landscape and Interior Design consultancy for Residential, Commercial, Gated Communities, Theme Parks, Boutique Hotels, Luxurious Villas and Hospitality Projects and should have won awards of national/international repute.
- 3. The following scanned documents in .pdf file format must be attached with the Bid:
  - a) Letter of Bid in the format prescribed conveying their unconditional acceptance to the terms and conditions of the tender enquiry.
  - b) The firm must enclose with their Technical Bid, the attested copy of their firm's Registration, unconditional acceptance to the delivery schedule prescribed on their letterhead, TIN of the Firm, Pan Card of the firm, Banker details, Income Tax Return for the last year, details along with scanned copies of the certificates towards the awards won by them, the list of their valued customers along with copies of earlier work orders executed by them for similar Horticulture and Beautification works may be submitted along with the quotation.
  - c) Bidders should submit without fail a colour copy of their Design concept and should also submit a 3-D animated walk-through of the work offered by them. The hard copy of the Design concept should be submitted along with EMD and soft copies of both Design Concept and 3-D animated walk-through should be uploaded on the Procurement Portal. As the work to be carried out is creative and aesthetic in nature, Offers not enclosed with Design concept and 3-D animated walk-through shall be considered invalid and will be rejected forthwith.
  - d) Since the work is very urgent in nature, firms not in a position to accomplish the work on assignment within 15 days need not respond to the tender enquiry.
  - e) Scanned copy of Earnest Money Deposit of Rs.85,000/- (Rupees Eighty Five Thousand only) in the form of Demand Draft drawn in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Hard copy of the Demand Draft is to be sent so as to reach before closing date of tender enquiry at the address of The Administrative Officer (Admn.), S.V.P. National Police Academy, Shivarampally, Hyderabad. Offers received without the prescribed EMD, will be rejected summarily.
  - f) The scope of work indicated in the Annexure-A of Tender Enquiry should be strictly complied with and deviations if any at the execution stage shall be viewed seriously.

- 4. In the financial bid, the total amount for designing and undertaking the work as per the scope defined in Annexure-A including all taxes, transportation charges, labour charges, etc. are to be quoted explicitly both in words and figures. No figures or words should be overwritten. Overwritten figures or words should be scored out and re-written under full signature of the authorized signatory. Quotations that do not fulfil this condition will not be considered.
- 5. The prices once accepted shall remain valid/fixed till the successful execution of the complete work order to the satisfaction of the Competent Authority of the Academy. The Academy will not entertain any increase in the value of work during the execution stage for any reasons whatsoever thereof.
- 6. Prices shall be quoted in Indian rupees only.
- 7. The Bid / Tender submitted shall necessarily remain valid for **180 days** after the date of bid opening. If any bidder withdraws his tender before the said period, SVP NPA without prejudice to any other right or remedy will be at liberty to forfeit the Bid Security/EMD submitted along with the bid.
- 8. No interest will be paid on Earnest Money Deposit and the EMD of unsuccessful tenderers will be returned in due course of time. If the quotation is accepted and the contracted firm fails to undertake the work order in the stipulated time frame, their EMD will be forfeited without any further notice.
- 9. The Director, SVP National Police Academy <u>reserves the right to accept/reject</u> any or all the bids without assigning any reason.
- 10. The bidding firm should take a strict note, that they would adhere strictly to the delivery schedule indicated in this tender document, failing which they would be penalised with a penalty **equal to 0.5%** of the work order value for every day's delay.
- 11. The work order is liable to be cancelled, if the progress/quality of work is found to be **not satisfactory**.
- 12. The bidder will be blacklisted by the Academy in case of the above condition being invoked duly forfeiting the EMD submitted by him.
- 13. The bidder should sign at the bottom of each page of tender form.
- 14. The SVP NPA reserves the right to increase or decrease the scope of work as defined in the work order.
- 15. Terms of Payment 100% Payment will be made only after completion of work & necessary certification towards satisfactory completion of work by the competent authority of the Academy. However, request for Mobilisation advance as admissible under Rules will be considered.
- 16. The Director SVP NPA reserves the right to cancel the order without prior notice, forfeit the EMD/security deposit or recover any damages for any breach of contract.

17. Notwithstanding any of the conditions and clauses indicated in the Tender form, the Director has the whole and sole right to waive off any of the above clauses, accept or reject either the lowest or any other valid bid and to assign the work to more than one bidder or to cancel the entire Tender Enquiry without assigning any reasons thereto.

#### 18. Evaluation of Bids:

- i) As the work to be carried out is creative and aesthetic in nature, Offers not enclosed with Design concept and 3-D animated walk-through shall not be considered and will be treated as invalid and rejected forthwith.
- During evaluation of the bids, the Academy may at its discretion, ask the Bidder for clarifications on its bid. The clarification of the bidder shall be in writing.
- ii) No bidder shall contact the purchaser on any matter relating to its bid from the time of the bid opening to the time the purchase order is placed. If the Bidder wishes to bring additional information to the notice of the Purchaser it should be done in writing.
- iii) Any effort by a bidder to influence the Purchaser in its decisions on bid evaluation, bid comparison or purchase order decision will result in rejection of the bid.
- iv) Arithmetical errors in the bids, if any, will be rectified on the following basis:- If there is a discrepancy between words and figures, the lower of the two shall be taken as the bid price. If the bidder does not accept the correction of errors, as aforesaid, its bid will be rejected, and its EMD will stand forfeited.

#### 19. Eligibility Conditions:

- i) The bidding firm should not have been blacklisted/ debarred/suspended by any Government Department/Organization/Undertaking.
- ii) The Vendor should be an entity registered in India.

#### 20. Taxes and duties

- i) Vendor shall be entirely responsible for all taxes, duties, license, fees etc. incurred until the successful completion of work at the Academy. As such, the amount quoted shall be inclusive of all taxes, levies including designing and professional charges, if any. The rates quoted will be treated as all-inclusive and no further claims whatsoever will be entertained in this respect.
- ii) No bid will be considered unless and until all the pages / documents comprising the bid are properly numbered, signed and stamped by the person/s authorized to do so.
- 21. <u>Demonstration of the offered solution</u> The bidder should be able to provide complete demonstration of the work being undertaken by them, in case the Tender Purchase Committee so desires. Failure to offer demonstration shall entail rejection of bid forthwith.

## SPECIFICATION OF HORTICULTURE AND BEAUTIFICATION WORKS TO BE UNDERTAKEN AT S.V.P. NATIONAL POLICE ACADEMY

The purpose of undertaking the subject Horticulture and Beautification work is to make the Site-B of the Academy campus environmental friendly and also to make positive impression over our valued visitors and Dignitaries who visit the Academy for various training activities. The contractor has to design and undertake all such jobs/activities required to maintain the Academy campus in a presentable condition for all the time whether such activities are elaborated hereunder or not.

The beautification works are to be undertaken in the following areas:

- (1) Parade Ground -
- (a) Opposite Drop-off Area
- (b) Parade Ground Area (Internal & External)
- (2) Entrance of SVPNPA (Outside)-
- (a) Central Oval Mound outside the Entrance Gate, Decoration with seasonal blooms.
- (b) Side green buffers on entry and exit roads.
- (c) Plantation between Steel Cladded Pillars on Exterior Curved Wall
- (d) Curved Wall in front of Security Check
- (3) Entrance of SVPNPA (Inside)
- (a) Triangular Delta Mound
- (4) Michelangelo Road
- (a) 1<sup>st</sup> Sidewalks just after the entrance (both sides)
- (b) 2<sup>nd</sup> Sidewalks after the Auditorium (both sides)
- (c) Side walk left and right side.
- (d) 1<sup>st</sup> Sidewalk on left side of Michelangelo stone.
- (5) Beautification around Auditorium
- (a) Oval area with fountain.
- (b) Side entry of Auditorium.
- (c) Rear side of Auditorium between A.P. Conference Hall
- (6) Beautification of High Tea Area and connecting road from the Michelangelo's Stone.
- (7) Beautification near Sardar Vallabhbhai Patel Statue.
- (8) Beautification in front of A.P. Conference Hall.
- (9) Beautification near Rajasthan Bhavan.
- (10) Visual Barrier on the way of Rajasthan Bhavan.
- (11) Miscellaneous works such as installing of sandstone pots, planters, curios, sculptures, benches, etc.
- (12) Sardar Vallabhbhai Patel National Police Academy signage at entrance with SS or Brass Letters.

The brief scope of work to be undertaken by the Bidding firm in the above areas include the following:

- (a) Identify the various kinds of plants to be placed in various locations which suits and increases the aesthetics of the location giving a pleasant look for the visitors.
- (b) Excavation & removal of 1ft. depth old soil and lifting it inside area wherever required within campus with vehicles.
- (c) Supply of red soil\*\* & manure mixture with 3:1 ratio and levelling of ground.
- (d) Supply & undertaking plantation as per the design proposed.
- (e) All plant materials shall be fully-gown, specimen plants used for instant effect.
- (f) They shall be healthy, sound and vigorous free from plant diseases, insects, pests or their eggs and shall have healthy, well developed root systems.

\*\* while the **red soil** will be provided by the Academy, supply of the required plant materials, manure mixture and labour for undertaking the work including the lifting of removed old soil to inside area shall be undertaken by the Bidder.

<u>Site familiarization</u>: Before quoting, the Bidder in his own interest shall carry out site visit to know the site conditions and full implications of the assignment. This will also help him in proper assessment of the work. Failure to do so will not absolve the contractor of his responsibility to carry out the work as specified in the Tender Documents. The cost of visiting the site shall be borne by the Contractor and shall be at his own responsibility and risk.
