Sardar Vallabhbhai Patel National Police Academy, Hyderabad, the premier Police Training Institution of our country, invites quotations for repairing of ESTP located at Advance Courses Mess at Site-B of the Academy as per details given below:-

S/No	Description of repair / work
1.	Blower 5 kw gearbox repairing, changing of gears and alignment
2.	Carbon media changing, internal pipeline changing
3.	Bacteria media changing
4.	UV light not functioning and needs to be replaced

2) Terms and Conditions

- a) The bidders should have at least two years of experience in the field and must enclose copy of certificate of their firm's registration with CPWD or any other Govt agencies along with the quotation.
- b) <u>Site Visit</u>: Interested vendors may visit the site before submitting the quotation after taking prior permission from the Assistant Commandant (Works) of SVP NPA Hyd.
- c) Earnest Money Deposit: EMD of Rs. 2100/- (Rupees two thousand one hundred only) should be enclosed in the form of demand draft dawn in any commercial bank in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. FMD of unsuccessful tenderers will be returned in due course of time
- d) <u>Terms of payment</u> No advance payment or payment against proforma invoice will be made. Payment will be made only after completion of work.
- e) The work should be completed within 15 days from the date of receipt of work order from the Academy
- f) The bid should be valid for 180 days from the date of opening of bid.
- g) The entire scope of work as defined above shall be treated as a single work and no offer in piece meal shall be accepted

- h) In case of deviations, the same shall be explicitly indicated in a separate statement
- i) The total cost of work shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of execution
- j) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- k) The work once entrusted, shall be completed in the time frame as stipulated in the work order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.
- l) In case of inordinate delay, the Academy reserves every right to cancel the work order, without any liability including forfeiting the EMD/Security deposit submitted, as the case may be.
- m) The bidder will be blacklisted by the Academy in case of (column-l) above being invoked.
- n) Water and electricity charges arising during the period of execution, shall be to the Contractors account
