1.	SVP National Police Academy, Shivrampally, Hyderabad, invites <b>e-bids</b> under two-bid system (Technical Bid and Financial Bid from reputed firms/vendors/registered supplier/stockist for supply of <b>Multinational Branded Medicine with their brand names on Rate Contract (RC)</b> to SVP National Police Academy Hyderabad for the year 2021-22 which are to be supplied as and when requisition placed.

4. Interested manufacturers/ authorised dealers/stockists/suppliers dealing with above said medicines and other items can download the tender document from CPP Portal ([www.eprocure.gov.in](http://www.eprocure.gov.in)) and bid can only be submitted through the same website. Bid submitted other than on CPP Portal will not be accepted. The eligible

bidders should have the digital signature certificate (DSC) issued from any agency authorised by controller of certifying authority (CCA), Govt. of India.

5. **Terms and Conditions.** In this NIT, Purchaser means The Director, Sardar Vallabhbai Patel National Police Academy or any other officer authorised on his/her behalf :-

(a) The bids are invited online under two cover system (Technical Bid Cover-1) and Bid of Quantity (BOQ) (Cover-2) from eligible bidders.

(b) Tender shall be submitted online only at CPPP website. Bidders are advised to refer the Bidders manual kit for e-submission of the bids online through the Central Public procurement portal available at the website: <http://www.eprocure.gov.in>. Aspiring Bidders/ Suppliers who have not enrolled/registered in e-procurement should enrol/register before participating through the website <http://www.eprocure.gov.in>. The portal enrolment is free of cost.

(c) The contract when awarded will remain operative for a period of one year from the date of commencement of contract. In the interest of state economy or administrative necessity, the Director may extend the operation of contract beyond one year till three months and in that case the contractor will be bound to supply the contracted items at the same contracted rates and under the same terms and conditions. Extension of contract beyond extended three months may be made only on mutual agreement between the contractor and the Contract Operating Officer.

(d) Tax imposed by State Government (if any) from time to time on contracted items will be deducted from the contractor's bill and deposited to State Government under appropriate budget head/revenue head.

**(e) The highest percentage of discount item wise will be the only criteria for deducing L1.**

**(f) In order to avoid over storage and subsequent the expiry of medicines thereto, the medicine will be purchased in piecemeal frequently and supply should be made within one week without fail.**

**(g) Only branded medicine (with generic value) to be quoted. Latest Batch items only shall be supplied.**

(h) Conditional tenders/bid will not be accepted. Bidder should clearly indicate additional charges involved in operation of contract, if any. Offers with stipulation like "if applicable" will be treated as vague and shall be ignored.

(j) The department may ask for production of original document submitted by the bidder for verification to confirm the correctness. If any document submitted by firm/bidder is found to be fake/not legitimate at any stage of tender, the penal action as per provision of contract will be initiated.

6. Bidders can access and download the tender documents from CPP Portal and can fill them with all relevant information and submit the completed tender documents online on the website: <http://www.eprocure.gov.in>. The downloading of tender documents shall be carried out strictly as provided on the website. No editing, addition, deletion of matter shall be permitted. If such action is observed at any stage, such tenders are liable for outright rejection.

7. All the documents as per tender requirement should be uploaded online and further, no documents will be accepted offline. However, **TDR(Term Deposit Receipt)/ BG (Bank Guarantee) (EMD- Earnest money deposit) hard copy should be sent to SVP National Police Academy before the due date of opening.** Bidders who are not submitting any of the required documents online will summarily be rejected.

8. The details of the Tender documents and EMD should be filled and uploaded online. Earnest Money Deposit (EMD) for **Rs.50,000/- (Rupees fifty thousand only)** (Refundable) should be deposited in form of TDR(Term Deposit Receipt)/Bank Guarantee drawn on any nationalized bank in favour of 'The Director, SVP National Police Academy, payable at SBI, Shivarampally, Hyderabad which should be valid for a period of 180 days from the date of opening of tender. **Bids without EMD will not be considered. Tender Reference Number or details should be mentioned on the backside of the original EMD** and the same should be sent to SVP National Police Academy, Hyderabad before due date of opening of the tender. **MSME firms/bidders are exempted for submission of EMD.** The bidder may also remit through RTGS to Director NPA Administration Account No. 52020141259, SBI Shivrampally, IFSC Code : SBIN0020335 and proof of which must be attached to their bid document accordingly.

9. The TIA (Tender inviting authority) will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders at the eleventh hour. 10. Following scanned documents in PDF/Excel file format must be uploaded in respective covers duly signed and stamped.

**Documents to Accompany First Cover (In PDF)**

(a) No bid will be considered unless and until all the pages/documents comprising the bid are properly numbered, signed and stamped by the persons / authorized to do so.

(b) The firm must upload attested and scanned copy of following documents:-

- (i) Firm Registration certificate as per Companies Act of India.
- (ii) GST Registration alongwith latest submitted return.
- (iii) PAN Card of the firm.
- (iv) Income tax returns of last three financial years (2017-18, 2018-19 & 2019-20).
- (v) Cumulative turnover of last three years should be at Rs.50,00,000/- duly supported by the audited financials reports.
- (vi) Copies of earlier contract/work order executed in the past.
- (vii) Filled in Commercial Information of firm in .xls format (Uploaded in website alongwith NIT) to include Banker's and firms details.
- (viii) LOB (Letter of bid).
- (ix) Scanned copy of EMD. **Offers received without the prescribed EMD, will be rejected summarily** and original EMD should reach before opening the technical bid. **MSME firms/bidders are exempted for submission of EMD.**

**Second Cover :-**

(c) **The Financial bid (In excel file BoQ)** :- The overall highest percentage of discount to be offered for the each Annexure, the BOQ template must not be modified or replaced by the bidder, else the bid submitted is liable to be rejected. No reduction in quoted % of discount on MRP will be considered during the currency of contract (including extendable period).

(d) The % discount once accepted by the purchaser shall remain fixed for the currency of contract (including extendable period) and valid till the successful execution of the complete order to the satisfaction of the purchaser.

(e) The cost of medicine **shall be inclusive of all the Taxes/duties (including GST), freight and forwarding charges, handling charges, loading and unloading charges, insurance charges, etc.**

(f) Prices shall be quoted in Indian rupees for billing purpose.

11. **“Only MRP printed stocks to be supplied.” Do not supply “Hospital supply not for sale” and also do not supply “Hospital supply with MRP”.**

12. The details of the required Medical and allied Items are shown in the Annexure A, B & C attached. **All Medicine Items are mentioned in the Annexure ‘A’, Surgical & Other Items in Annexure ‘B’ and Lab & X-Ray Items in Annexure ‘C’.** The quantity mentioned is only probable requirement and may increase or decrease as per the actual requirement. The approved percentage of discount should not vary with the quantum of the order.

14. The specification of each product should be as per the details given in the Annexure ‘A’, ‘B’ & ‘C’ attached. Any variation will result in the rejection of the product.

15. Clerical error etc., committed by the tenderer in the tender forms shall not be considered after opening of the tenders.

16. Conditions such as “subject to availability”, “supplies will be made as and when supplies are received” etc., will not be considered under any circumstances and the tenders of those who have given such conditions shall be treated incomplete and for that reason, shall be summarily rejected.

17. If the supplies are declared to be not of standard quality or spurious or adulterated or mis-branded, such batch/batches will be deemed to be rejected goods. If any Medical Items supplied by the tenderer is partially or wholly used or consumed after supply and is subsequently found to be not as per specifications, unsound, inferior in quality or description or are otherwise faulty or unfit for consumption by the purchaser, then the cost of such Medical Items will be recovered from the tenderer, if the payment had already been made, in addition to penalty for the entire batch. Further the purchaser reserve the right to procure the stocks from other sources.

18. The Purchaser will be at liberty to terminate the contract without assigning any reasons thereof either wholly or in part on one month’s notice. The tenderer will not be entitled to any compensation whatsoever in respect of such termination.

19. If the tenderer fails to execute the supply within the stipulated time, the Purchaser is empowered to make emergency purchases and claim the difference in total cost from the tenderer in addition to other penal clauses.

20. All the supplies will be scheduled for the period from the date of acceptance till the completion of the tender in installments, as may be stipulated in the supply order. The supplied Medical Items should have minimum potency for the maximum period as

prescribed in the Drugs and Cosmetics Act 1940 and rules thereunder on the date of supply. It shall be responsibility of the tenderer for any shortages, damages at the time of receipt in the Stores and Purchaser is not responsible.

21. To ensure sustained supply without any interruption the Purchaser reserves the right to split the orders for supplying the requirements among more than one tenderer, provided that, the rates and other conditions of supply are equal.

22. If any articles or things supplied by the tenderer have been partially or wholly used or consumed after supply and are subsequently found to be in bad order, unsound, inferior in quality or description or otherwise faulty or unfit for Consumption, then he contract price or prices of such articles or things will be recovered from the tenderer, if payment had already been made to him. Otherwise the tenderer will not be entitled to any payment whatsoever for such article.

23. Non performance of contract provisions will provide the base to disqualify a firm to participate in the tender for the next five years.

24. The Bid / Tender submitted shall necessarily remain valid for 180 days after the date of financial bid opening and percentage of discount on MRP. If any bidder withdraws his tender before the said period, SVP NPA shall-without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security submitted along with the bid.

25. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time. If the bid is accepted and the contracted firm fails to undertake the supply contract, their EMD will be forfeited without any further notice.

**26. The tenderer should supply the said medical items with at least 12-18 months validity i.e date of expiry from the date of supply.**

**27. The medicine which are purchased through Rate Contract should be replaced by the supplier three months before expiry of the same.**

**28. Projected quantities may vary as per the actual requirement from time to time.**

29. The successful tenderer has to enter into an agreement with the Academy for smooth supply of medicines and allied items during the currency of contract.

30. The Academy has the right to entrust the supply of medicines to one or more firms/agency/wholesalers, in case of equal rate offered.

31. The bidding firm should note that they would adhere strictly to the delivery schedule indicated in indent for supply of items failing which a penalty **of 0.5% per day will be levied against** the indented value where the delay is reported Subject to maximum 10% of the contract value unless extension is obtained in writing from the office on valid ground. Further in case of inordinate delay of 4 weeks from the date of supply order, the supply order stands cancelled and penal action as per provision of contract will be initiated without any further notice.

32. The Tender Processing Committee nominated for the purpose may visit the site wherever the stores placed or the manufacture site to verify the quality of medicines.

33. Notwithstanding any of the conditions and clauses indicated in the Tender form, the Director has whole and sole right to accept or reject either the lowest or any other valid bid and or **split up the order** for supplying of above items to more than one bidder or to cancel the Tender without assigning any reasons thereto.

34. The makes/brands of the items offered and accepted by the Academy shall not be subjected to change, until and unless agreed to by the Competent Authority of the Academy.

35. The supplies are liable for test/quality check if the competent authority required.

36. The date of placing the supply order shall be the date of dispatch of supply order or the delivery thereof to the tenderer, when such supply order is being delivered through some other person or through mail.

37. **Penal Action for Non-Compliance of Terms and Condition of the Contract.**

(a) EMD of a tenderer is liable to be forfeited if he withdraws his bid (any time after deposition of tender or before accepting the contract.

(b) EMD of a tenderer may also be forfeited if the tenderer derogates any terms/conditions of the tenders, raises conditions with malafide intention to delay/scuttle tender procedure or quotes fictitious/unrealistic rates/percentages.

(c) If a contractor will fully neglects or fails to perform or observe any condition of the contract or attempts to cheat or indulge in fair practices with the motive of making undue gain, the Director may impose a ban on future contracts by the SVP National Police Academy with that contractor.

(d) In case a contractor fails to comply with any demand or indent place by the Academy Hospital or to perform his part of the contract to the entire satisfaction of the Academy or fails to abide by the terms of the contract, the contractor shall be liable to all following actions or any of the following actions, as may decided by the Director to this Academy :-

(i) Forfeiture of Performance Security in whole or in part.

(ii) To make good the loss caused to the Government.

(iii) Cancellation of the contract without any prior notice to the contractor.

(iv) Debarment/black listing from entering into contract with the Academy for Period specified by the competent authority.

(e) All losses sustained by the government due to failure, omission or neglect of the contractor may be realized from the performance security or any other amount, which may be due to be paid to contractor from the Academy.

(f) In event of contractors performance security deposit being reduced by means of forfeiture, the contractor within 15 days from the date of intimation of the reduction shall restore the performance security to the original value, failing which, the Contract Operating Officer will recover the amount involved from any amount due to the contractor by the government or from any other assets of the contractor held with the Academy.

(g) The bidder will be blacklisted by the Academy in case of breach/non-compliance of terms and condition of contract.

(h) The Director SVP NPA reserves the right to cancel the order without pre-notice, forfeit the security deposit or recover any damages for any breach of contract.

38. **Performance Security Clause :-** The successful bidder on receipt of Letter of Acceptance should submit a FDR(Fixed Deposit Receipt)/Bank Guarantee (3% of the contract value) issued by any Nationalized Bank in favour of the Director, SVP National Police Academy, Hyderabad payable at SBI Shivarampally, Hyderabad within 15 days of the placement of order for due performance as per the provisions contained in GFR-171. Failure on the part of the firm to deposit the performance security within stipulated time the purchase reserves the right to cancel the letter of acceptance. Performance security submitted by the bidder will remain valid for a period of **Seventeen months** beyond the date of completion of all contractual obligations of the supplier. No interest will be payable for "Performance Security".

39. **Right to Cancel the Order.** The Director, SVP National Police Academy reserves the right to cancel the tender at any stage of tender process and the work order may be cancelled without any financial repercussion on either side and without seeking the consent of the bidder. No further correspondence in this matter will be entertained.

40. **High Court for Settlement of Dispute.** If the dispute between the parties not settled by the Arbitrator, it should be subject to the jurisdiction of the High Court of Judicature at Hyderabad.

41. **Arbitration Proceedings.** Any dispute arising out of the contract at any time between the parties hereto touching or arising out of this contract shall be referred to an arbitrator to be nominated by the Director, SVP National Police Academy and the decision and award of such arbitrator shall be final and binding upon the parties hereto and the provision of the Indian Arbitration Act 1996 shall apply to the Arbitration proceedings.

42. **Death of Contractor (Sole Proprietor).** In case of death of a contractor or sole proprietor of a firm, his/her legal heir (s) may be permitted to operate the contract already approved in favour of the deceased and are operational or operating the current contract approved in favour of the deceased :-

(a) Death Certificate of the deceased contractor.

(b) Willingness certificate on an affidavit that the legal heir (s) and accredited agent (s) is/are willing to continue the operation of existing contract (s) at the existing terms and condition of the contract.

(c) Legal Heir Certificate/Succession Certificate from the Court of Law.

43. **Payment of Bills.**

(a) The contractor should submit bill in triplicate to the Academy immediately after supply for payment.

(b) Bills submitted by the contractor will have GSTIN printed on it. Any bill received without GSTIN printed on it will be liable to be rejected.

(c) Payment of bill will be generally cleared within 45 days of receipt of bill/s. All payment would be made through e-payment. Hence, organization details in specified format must be submitted alongwith the bills.

44. **Opening and Evaluation of Technical Bids:-**



(a) The Tender Committee appointed by the Competent Authority of Academy will open all Technical Bids in the first instance on the appointed date and time at SVP NPA Hyderabad.

(b) During evaluation of the bids, the purchase committee may, at its discretion, ask the Bidder for clarifications of its bid. The clarification of the bidder shall be in writing.

(c) No bidder shall contact the committee member on any matter relating to its bid from the time of the bid opening to the time the purchase order is placed. If the Bidder wishes to bring additional information to the notice of the Purchaser it should be done in writing.

(d) Any effort by a bidder to influence the Purchaser in its decisions on bid evaluation, bid comparison or purchase order decision will result in rejection of the bid.

(e) The results of the evaluation of the Technical Bids along with the date of opening of the Financial Bids will be uploaded in the portal. The purchase committee may at its option to choose to open the financial bids immediately after the opening and evaluation of the Technical Bids.

45. **Opening and evaluation of Financial Bids:-**

(a) The Tender Processing Committee will open the financial bids in favour of vendors who successfully qualified technical bid.

(b) Arithmetical errors will be rectified on the following basis:- If there is a discrepancy between words and figures, the higher percentage of discount on MRP of the two shall be taken. If the bidder does not accept the correction of errors, as aforesaid, its bid will be rejected, and its EMD will stand forfeited.

46. **Eligibility Conditions :-**

(a) Any Government organization/undertaking should not have blacklisted debarred/suspended the bidding firm.

(b) The Vendor should preferably be an entity registered in India.

(c) The firm/agency/distributor/wholesaler with sound financial position are only eligible to submit the tender form.

(d) The successful bidder should produce a certificate from the Drugs Controller or an affidavit stating that there is no case pending against the firm under the Drugs Act.
