Sardar Vallabhbhai Patel National Police Academy, Hyderabad, the premier Police Training Institution of our country, invites quotations construction of four wheeler and two wheeler parking shed at BCTC area in Site-B of the Academy as per details given below:-

a)	Size - Four wheeler shed - 21 mtrs x 7 mtrs

b)	Earth works in excavation all kinds of soil
c)	Providing and laying in position cement concrete
d)	Structural steel work riveted bolted or welded in built up sections, trusses and framed work, including cutting, hoisting
e) f)	Providing and fixing G I profile sheet with necessary fittings Providing and applying of synthetic enamel paint

2). Terms and Conditions

- a) The bidders should have at least five years of experience in the field and must enclose copy of their firm's registration certificate and copies of earlier work order of same nature along with the quotation.
- b) <u>Site Visit</u>:- Interested vendors may visit the site before submitting the quotation after taking prior permission from the Assistant Commandant (Works) of SVP NPA Hyd..
- Earnest Money Deposit :- EMD of Rs.9,700/- (Rupees nine thousand seven hundred only) should be enclosed in the form of demand draft dawn in any commercial bank in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time
- d) <u>Terms of payment</u> No advance payment or payment against proforma invoice will be made. Payment will be made only after completion of work.
- e) The work should be completed within 12 days from the date of receipt of work order from the Academy

- f) The bid should be valid for 180 days from the date of opening of bid.
- g) The scope of work as defined above shall be strictly adhered to.
- h) In case of deviations, the same shall be explicitly indicated in a separate statement
- i) The total cost of work shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of execution
- j) The period of completion of the work shall be indicated in the offer.
- k) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- The work once entrusted, shall be completed in the time frame as stipulated in the work order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.
- m) In case of inordinate delay, the Academy reserves every right to cancel the work order, without any liability including forfeiting the EMD/Security deposit submitted, as the case may be.
- n) The bidder will be blacklisted by the Academy in case of (column-n) above being invoked.
- o) Water and electricity charges arising during the period of execution, shall be to the Contractors account
- p) Warranty The work executed shall carry a minimum warranty period of 06 months year from the date of completion and handing over of the work.
- q) Performance security: The successful bidder shall have to deposit a performance security of 5% of the contract value of the supply / work order rounded up to next hundred in the form of account payee demand draft / bank guarantee from a nationalized / scheduled commercial bank in favour of the Director, SVP NPA Hyderabad payable at SBH Shivrampally, Hyderabad within 15 days of the placement of supply order for due performance as per the provisions contained in GFR 158. Failure on the part of the firm to deposit the performance security within stipulated time the purchaser reserves the right to cancel the Supply Order. Performance Security submitted by the bidder will remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. No interest will be payable for "Performance Security."

Parties interested in carrying out the above work and on acceptance of the above terms and conditions, may submit their quotation along with EMD in a sealed cover addressed to the undersigned and duly superscribed as "construction of parking shed (four wheeler & Two wheeler) at BCTC Area in site -B of SVP NPA Hyderabad".- Not to be opened before 09 Feb 2016 (1700 hrs)
