9. **Terms and Conditions.**

- (a) Tender should be accompanied by a Demand Draft for Rs.3,700/-, Earnest Money Deposit drawn in favour of 'THE DIRECTOR, S.V.P. NATIONAL POLICE ACADEMY, HYDERABAD'. Tender not accompanied by prescribed EMD, will not be considered and will be summarily rejected.
- (b) Delivery/Installation is to be completed within 30 days from the date of Supply Order failing which, penalty @ 0.5% of the Supply Order value will be recovered for every week period delay from the final payment. Further in case of inordinate delay of 45 days from the date of Supply Order, this supply order stands cancelled without any further notice and you will also be liable to be blacklisted.
- (c) The date of placing the order shall be the date of dispatch of order or the delivery there of to the tenderer, when such order is being delivered through some person.
- (d) If the tenderer fails to provide the digital signature token within stipulated delivery period then the supply order will stand cancelled and the security deposit shall be forfeited. In addition, the tenderer may be blacklisted for a period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same product(s) will be awarded to the L2 tenderer based on the same documentation & processes.
- (e) After the expiry of the stipulated delivery period, which includes extension period if any, no item shall be accepted by SVPNPA. If the tenderer applies for the extension of the delivery period, the extension can be granted on valid grounds only once and upto a maximum of 30 days.
- (f) Payments would be made only after the receipt of all the items ordered in the supply order. In cases, where party supply has been made and the supply order for the remaining items has been cancelled, payment would be made for the supplied items after deducting the penalty, if any.

13. The Academy reserves the right to accept or reject the tenders without assigning any reasons thereof.
