Sub: Tender Enquiry Notice for removing of old Shahabada stone and re-fixing of kerb stone near riding ground saluting base to Orissa Bhawan at a length of 90 meters at Site-A of SVP NPA Hyderabad-Regarding.

Sardar Vallabhbhai Patel National Police Academy, Hyderabad, the premier Police Training Institution of our country, invites quotations for removing of old Shahabada stone and re-fixing of kerb stone near riding ground saluting base to Orissa Bhawan at a length of 90 meters at Site-A of the Academy as per details given below:-

## 2) Terms and Conditions

- a) The bidders should have at least two years of experience in the field and must enclose copy of certificate of their firm's registration with CPWD or any other Govt agencies along with the quotation.
- b) <u>Site Visit</u>: Interested vendors may visit the site before submitting the quotation after taking prior permission from the Assistant Commandant (Works) of SVP NPA Hyd.
- c) <u>Earnest Money Deposit</u>: EMD of Rs. 4000/- (Rupees four thousand only) should be enclosed in the form of demand draft dawn in any commercial bank in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time
- d) <u>Terms of payment</u> No advance payment or payment against proforma invoice will be made. Payment will be made only after completion of work.
- e) The work should be completed within 30 days from the date of receipt of work order from the Academy
- f) The bid should be valid for 180 days from the date of opening of bid.
- g) The entire scope of work as defined above shall be treated as a single work and no offer in piece meal shall be accepted
- h) In case of deviations, the same shall be explicitly indicated in a separate statement
- i) The total cost of work shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of execution

- j) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- k) The work once entrusted, shall be completed in the time frame as stipulated in the work order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.
- l) In case of inordinate delay, the Academy reserves every right to cancel the work order, without any liability including forfeiting the EMD/Security deposit submitted, as the case may be.
- m) The bidder will be blacklisted by the Academy in case of (column-l) above being invoked.
- n) Water and electricity charges arising during the period of execution, shall be to the Contractors account
- Parties interested in carrying out the above work and on acceptance of the above terms and conditions, may submit their quotation along with EMD in a sealed cover addressed to the undersigned and duly superscribed as <u>"Removing of old Shahabada stone and re-fixing of kerb stone near riding ground saluting base to Orissa Bhawan at a length of 90 meters at Site-A of SVP NPA Hyderabad".- Not to be opened before 29<sup>th</sup> Nov 2016 (1700 hrs)</u>
