**NOTICE INVITING QUOTATIONS FOR SUPPLY OF RED MUD SOIL AND COW DUNG
TO THE SVP NPA HYDERABAD FOR THE YEAR 2017-18.**

Dear Sir,

The Academy invites separate sealed tenders for supply of the following items for Horticulture purpose:-

- i) Supply of 60 trucks of (200 Cft each) fine red mud soil for one year.
- ii) Supply of 60 trucks of (200 Cft each) dry cow dung manure for one year.

2. Parties interested in supplying one or all of the above items to the Academy for a period of one year subject to the following conditions, may please arrange to send their quotations latest by 31/08/2017:-

- (a) The rates once quoted shall remain firm and fixed and shall not be subjected to any variation during the currency of the contract for any reason whatsoever.
- (b) The quantities required shall be subjected to change in the mid of the year as per the needs of Academy.
- (c) The quantities contracted and amended from time to time shall be strictly adhered to.
- (d) Failure to deliver the ordered items in time shall entail imposing of penalty as per the discretion of competent authority of the Academy and a the rate as deemed fit.
- (e) The supplies shall be made as per requirement basis.
- (f) The Academy reserves the right to cancel the entire purchase order or part thereof without assigning any reasons.
- (g) If the performance is found to be not upto the mark, the security deposit is liable to be forfeited, if deemed fit.
- (h) Any Government Organization/undertaking should not have blacklisted debarred/ suspended the firm.
- (j) The Vendor should preferably be an entity registered in India.
- (k) In case your quotation is accepted ^{and} order is placed on you, the supply against the order should be made within the period stipulated in the order. Academy reserves the right to recover any loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle the Academy the imposition of penalty without assigning any reasons @ 1 /2% (half percent) of the total value of the item covered in order as penalty per day subject to a maximum of 5% (five percent) unless extension is obtained in writing from the office on valid ground before expiry of delivery period.

- (l) Liability of the work order getting cancelled, if the quality/progress of the work is found to be not satisfactory or if there is an inordinate delay of more than 4 weeks in completing the supply.
 - (m) You will be blacklisted by the Academy in case of (l) above being invoked.
 - (n) The supply will be unloaded in SVP NPA Campus, as directed by Horticulture Section Staff.
 - (o) The loaded truck to be weighed at the weighing balance and weighed when unloaded, the weighing charges have to be borne by the vendor.
 - (p) The supply will be taken as and when required by the Academy.
 - (q) The supply of Red Soil truck/ Cow Dung truck should be made through a capacity truck 200 CFT.
 - (r) The supply of cow dung/red soil should be suitable for agricultural purpose.
 - (s) The supply of Dried up or wet cow dung should be made based upon the requirement.
 - (t) The weighing should be done in front of NPA staff.
3. If the above terms and condition are agreeable to you, you may submit your quotation alongwith Earnest Money Deposit (EMD) amounting to **Rs.9000/- (Rupees Nine thousand only)** in the form of Demand Draft, favouring **The Director, SVP National Police Academy, Hyderabad. Tender not accompanied by earnest money will not be considered and will be summarily rejected.**
 4. Further on accepting your offer and on placing purchase order, you will submit Security Deposit for amount as indicated in the purchase order, which will be about 5% of the purchase contract value, in the form of a Bank Guarantee/FDR drawn in favour of **"The Director, SVP National Police Academy, Hyderabad"**. The performance security should be valid upto one year.
 5. The sealed cover containing the quotation alongwith EMD be duly 'superscribed as **'Quotation for supply of red mud for the year 2017-18-Not to be opened before 31/08/2017 & Quotation for supply of cow dung for the year 2017-18 – Not to be opened before 01/09/2017.**
 6. The last date for receipt of quotation is 31/08/2017 (1700 Hrs.) and quotation will be opened on 01/09/2017 by the designated committee.
