- Interested manufacturers/ authorised dealers/ stockists/ suppliers dealing with above items can download the tender document from CPP Portal (<a href="www.eprocure.gov.in">www.eprocure.gov.in</a>) and bid can only be submitted through the same website. Bid submitted other than on CPP Portal will not be accepted. The Eligible bidders should have the digital signature certificate (DSC) issued from any agency authorised by controller of certifying authority (CCA), Govt. of India.
- 5) The bids are invited online under two cover system (Technical bid (Cover 1) and price bid/bill of quantity (BOQ) (Cover 2)) from eligible bidders.
- Bidders can access and download the tender documents from CPP Portal and can fill them with all relevant information and submit the completed tender document online on the website: http://www.eprocure.gov.in. The downloading of tender documents shall be carried out strictly as provided on the website. No editing, addition, deletion of matter shall be permitted. If such action is observed at any stage, such tenders are liable for outright rejection.
- 7) Tender shall be submitted online only at CPPP website. Bidders are advised to refer the Bidders manual kit for e-submission of the bids online through the Central Public procurement portal available at the website: http://www.eprocure.gov.in. Aspiring Bidders/ Suppliers who have not enrolled/ registered in e-procurement should enrol/register before participating through the website http://www.eprocure.gov.in. The portal enrolment is free of cost.
- All the documents as per tender requirement should be uploaded online and further, no documents will be accepted offline. However, Demand Draft (EMD Earnest money deposit) hard copy should be sent to SVP National Police Academy before the due date of opening. Bidders who are not submitting any of the required documents online will summarily be rejected.

#### Terms and Conditions

- 1) The bid should be strictly as per the format prescribed in Annexure 'B' of NIT. In case of deviation the offer will be rejected
- 2) <u>Documents required to be submitted</u>:- The firm must enclose the following documents with technical bid:
  - a) Duly signed and stamped tender documents.
  - b) Proof of firm
    - i) firm's Registration, TIN of the firm & Pan Card of the firm
    - ii) copies of earlier supply orders etc along with the quotation.
  - c) Details of stores and feature of stores i.e specification viz. Make, Brand and Model and other information leaflets of the proposed brand which the bidder intends to deliver and the delivery schedule by the bidder.
  - d) Delivery and payment terms of items :- As per tender terms
  - e) LOB (Letter of bid).
  - f) Banker details of firm.
  - g) Any other documents.
- Syptem National Police Academy, Hyderabad' of value equal to the sum of EMDs of items offered by the vendor. The EMD prescribed for each item respectively has been specified in Annexure 'A' in this regard. No interest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time. Offers received without the prescribed EMD, will be rejected summarily.
- 4) <u>Price, tax and other charges:</u>- The Bid as per enclosed format shall comprise the price component indicating the unit price excluding taxes. The unit price thereof shall not be overwritten. (As per performa given Annexure in 'B')
  - a) The quoted price shall be exclusive of all the Taxes and taxes should be shown separately as applicable. No excess amount beyond the quoted amount will be considered.
  - b) In case the taxes are shown blank, then it will be construed that the rate is inclusive of all taxes.
  - c) Quoted prices should be inclusive of freight and forwarding charges, handling charges, loading and unloading charges, insurance charges, etc.
  - d) The prices once accepted by the purchaser shall remain valid till the successful execution of the complete order to the satisfaction of the Purchaser i.e upto 31/3/2018. The Purchaser shall not entertain any

increase in the prices during the period of contract. No price escalation will be allowed till the successful execution of the complete order. In the event there is a reduction or increase in Government levy/duties during the period of execution of the order, the rates shall be suitably adjusted with effect from the date of notifying the said reduction or increase in the Government levy/excise duty.

e) Prices shall be quoted in Indian rupees only.

Note: Individual item-wise L-1 ( lowest bidder ) and quality will be considered for placing work order.

- Bid validity: The Bid / Tender submitted shall necessarily remain valid for 365 days after the date of commercial bid opening. If any bidder withdraws his tender before the said period, Souvenir shop of SVP NPA shall-without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security submitted along with the bid.
- 6) <u>Undertaking certificate</u>: The bidding firm should submit an undertaking along with bid, that they would adhere strictly to the delivery schedule indicated in this tender document failing which they would be penalised with a penalty equal to 0.5% of the supply contract value for every week period's delay. Failure to enclose this undertaking would entail rejection of the submitted offer without any further intimation.
- 7) The **Bid** should be placed in one sealed envelope super scribed 'BID FOR SUPPLY OF MEMENTOS ITEMS TO SOUVENIR SHOP OF SVP NPA HYDERABAD and should be addressed to the AD (Works), SVP National Police Academy, Hyderabad.

The sealed tender received after the due date and time will be summarily rejected. The bid should be signed at the bottom of each page of tender form.

- 8) Souvenir shop of Academy will cancel work order, if the quality / progress of the work are found to be not satisfactory or if there is an inordinate delay in completing the supply.
- 9) The bidder will be blacklisted by the Souvenir shop of Academy in case of (column-8) above being invoked.
- 10) The Souvenir shop of SVP NPA reserves the right to cancel the order without pre notice, forfeit the security deposit or recover any damages for any breach of contract.
- 11) Notwithstanding any of the conditions and clauses indicated in the Tender form, the I/C Souvenir shop of Academy has whole nd sole right to waive off any of the above clauses, accept or reject either the Lowest or any other valid bid and or split up the order for supplying of various uniform articles to more than one bidder or to cancel the Tender without assigning any reasons thereto.

- 12) <u>Terms of payment</u> No advance payment or payment against proforma invoice will be made. Payment will be made only after installation.
- Performance security: The successful bidder will have to deposit a performance security of 5% of the contract value of the work order rounded up to next hundred in the form of account payee demand draft / bank guarantee from a nationalized / scheduled commercial bank in favour of the Director, SVP NPA Hyderabad payable at SBH Shivrampally, Hyderabad within 15 days of the placement of supply order for due performance as per the provisions contained in GFR 158. Failure on the part of the firm to deposit the performance security within stipulated time the purchaser reserves the right to cancel the Supply Order. Performance Security submitted by the bidder will remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. No interest will be payable for "Performance Security."
- 14) The I/C Souvenir shop of Academy reserves the right to increase or decrease the quantity of the order.
- The I/C Souvenir shop of Academy reserves the right to cancel the order without pre notice, forfeit the security deposit or recover any damages for any breach of contract.
- 16) <u>Sample :-</u> The technically qualified bidders should produce sample of the proposed Mementoe items before the committee at SVP NPA Hyderabad. The expenditure of samples will be at the cost of the vendor. At the second stage financial bids of only the technically acceptable offers shall be opened for further evaluation before awarding the contract.

### Opening and Evaluation of Bids:

- a) During evaluation of the bids, the Purchaser may, at its discretion, ask the Bidder for clarifications of its bid. The clarification of the bidder shall be in writing.
- No bidder shall contact the purchaser on any matter relating to its bid from the time of the bid opening to the time the work order is placed. If the Bidder wishes to bring additional information to the notice of the Purchaser it should be done in writing.
- c) Any effort by a bidder to influence the purchaser in its decisions on bid evaluation, bid comparison or work order decision will result in rejection of the bid.
- d) The Tender Committee appointed by the Purchaser will open the Financial Bids of bidders as specified in (e) above.
- e) At the time of evaluation quality and price of items will considered.

f) Arithmetical errors will be rectified on the following basis: If there is a discrepancy between words and figures, the lower of the two shall be taken as the bid price. If the bidder does not accept the correction of errors, as aforesaid, his bid will be rejected, and EMD will stand forfeited.

#### **Eligibility Conditions**

- a) The bidding firm should have the capability to supply the ordered items in time as per the schedule indicated in the salient features i.e. the supply shall be completed within 15 days from the date of receipt of purchase order.
- b) Any Government organization/undertaking should not have blacklisted debarred/suspended the bidding firm.
- c) The Vendor should preferably be an entity registered in India.
- d) No bid will be considered unless and until all the pages / documents comprising the bid are properly numbered, signed and stamped by the person/s authorized to do so

#### Taxes and duties

- a) Vendor shall be entirely responsible for all taxes, duties, license, fees etc. incurred until delivery of the contracted services to the Institute.
- c) In case the taxes are shown blank, then it will be construed that the rate is inclusive of all taxes.
