i)	Earnest Money Deposit (EMD).	EMD of Rs.17,600/- (Rupees seventeen thousand six hundred) should be enclosed in the form of demand draft drawn in any commercial bank in favour of 'The Director, S.V.P. National Police Academy, Hyderabad'. Offers received without the prescribed EMD, will be rejected summarily. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenderers will be returned in due course of time.
j)	Completion of work / completion period	The work should be completed within 15 days from the date of receipt of work order from the Academy.

k)	Bid validity	Bid should be valid for 180 days from the date of opening of bid.

- 4) Non transferable tender containing Specifications, Bid Evaluation criteria and Tender Terms & Conditions can be purchased on written request accompanied with payment of Tender Fee through DD drawn in favour of "THE DIRECTOR, SVP NATIONAL POLICE ACADEMY HYDERABAD. Tenderers may also download the tender enquiry documents from the website www.svpnpa.gov.in and submit their tender by utilizing the downloaded document, along with the required non-refundable fee as mentioned above.
- 5) Description of stores with details given below

S/No	Description of work
a)	Size of the Shed - Four wheelers = 16 mtrs x 10 mtrs and Two wheelers = 16 mtrs x 07 mtrs
b)	Earth works in excavation all kinds of soil
c)	Surface dressing of the ground including removing vegetation and inequalities not exceeding 15 cm deep and disposal of rubbish all kinds of soil
d)	Providing and laying in position cement concrete
e)	Structural steel work riveted bolted or welded in built up sections, trusses and frames work, including cutting, hosting.
f)	Providing and fixing G I Profile sheet with necessary fittings
g)	Providing and fixing GI profile sheet roofing gutter
h)	12 mm cement plaster of mix 1:4 (1 cement : 4 fine sand)
i)	Providing and applying of synthetic enamel paint
j)	Providing and laying 60mm thick factory made cement concrete interlocking paver block
k)	Providing and laying factory made kerb stone

6). Terms and Conditions

- a) The bidders should have at least five years of experience in the field and must enclose copy of their firm's registration certificate and copies of earlier work order of same nature along with the quotation.

- b) Terms of payment - No advance payment or payment against proforma invoice will be made. Payment will be made only after completion of work.
- c) The scope of work as defined above shall be strictly adhered to.
- d) In case of deviations, the same shall be explicitly indicated in a separate statement
- e) The total cost of work shall be indicated including all taxes and the rates shall remain firm and fixed and shall not be subjected to any variation at any stage of execution
- f) The period of completion of the work shall be indicated in the offer.
- g) The work executed shall carry a minimum warranty period of one year from the date of completion of work and handing over of the work.
- h) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of the bid / delay in receipt of the bid and such bid will be summarily rejected.
- i) The successful tenderer is required to submit a Security Deposit equal to 5% of the contract value in the form of a FDR/Bank Guarantee which should remain fixed/valid for a period of 3 months beyond the date of completion of all warranty obligations
- j) The security deposit so furnished will be returned only in case no latent defects are noticed/ surfaced in the work carried out and subject to furnishing of clearance certificate by the Works Section of the Academy.
- k) Both the EMD and Security Deposit are to be submitted in favour of "The Director, S.V.P National Police Academy, Hyderabad and payable at Hyderabad.
- l) The work once entrusted, shall be completed in the time frame as stipulated in the work order and in case of delay a penalty of 1% of the contract value is liable to be deducted from the final payment, for every week's delay.
- m) In case of inordinate delay, the Academy reserves every right to cancel the work order, without any liability including forfeiting the EMD/Security deposit submitted, as the case may be.
- n) The bidder will be blacklisted by the Academy in case of (column-n) above being invoked.
- o) Water and electricity charges arising during the period of execution, shall be to the Contractors account

7). Parties interested in carrying out the above work and on acceptance of the above terms and conditions, may submit their quotation alongwith EMD in a sealed cover addressed to the undersigned and duly superscribed as "Construction of vehicle parking shed (four wheelers and two wheelers) at rear side of STW building in site B of Sardar Vallabhbhai Patel, National Police Academy, Hyderabad".
