A 5-days Course on ‘**Economic Offences**’ is scheduled to be held at SVP National Police Academy, Hyderabad from **16<sup>th</sup> to 20<sup>th</sup> February, 2026** for the Officers of the rank of Addl. Superintendent of Police to Inspector General of Police and also for officers of equivalent ranks from other organization.

**2. The objective of the course is to enable the participants:**

- To have a better understanding about the genesis and magnitude of economic crimes.
- Review the existing laws, policing, procedures and other control mechanisms for tackling such crimes.
- Analyse the limitations and constraints in enforcement and to suggest ways and means for their resolution and
- Appreciate current and future trends in economic crimes with a view to exploring new strategies and tactics for effective tackling of such crimes.

3. It is requested that **three eligible officers** of the level of Addl. Superintendent of Police to Inspector General of Police from various Police units or officers of equivalent rank from other Organizations may please be nominated to attend the course as per the format given below: -



The Course is fully residential and the participants of the course will be staying in the accommodation provided by the Academy. **The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy, in respect of all Officers attending the course.** However, the expenditure on account of travel of officers for attending the course may be borne by the respective State / Central Government Departments. It is informed that as per SOP of the Academy, those Officers against whom any criminal case, DE/PE etc. is in currency or contemplated are **not eligible** to undergo any training programme/course/seminar at the Academy. Hence, nominations of eligible Officers may only be sent accordingly.

6. The dress order for the course participants is Civvies i.e. shirt (full sleeves), Trouser & tie for gentlemen and salwar kameez / saree / Business suit for ladies.

7. **The nominees may be advised to proceed for the course only after receiving confirmation of acceptance of their nominations from the Academy.** The Officers nominated for the course are required to report at the Academy by the **evening of 15<sup>th</sup> February 2026** i.e. one day before the commencement of the course. Transport from Hyderabad Airport / Railway station to Academy and back will be provided by the Academy as per travel plan provided by the participants.
