The S.V.P National Police Academy, invites sealed quotations from interested/prospective suppliers for supply of 40 Nos. of non-Geared Bi-Cycles for its Sports Section with technical specifications as indicated below :- .

- (a) Light weight classic frame for enhance riding comfort
- (b) Thin SLR white walled durable nylon tyres
- (c) Wheel and Pedal Reflectors
- (d) Sporty plastic chain covers
- (e) Frame height – 21”
- (f) Wheel Size – 26”
- (g) Ringing Bell & Lock

2. As such, all the tenderers fulfilling criteria are eligible to offer their bids. The documentary proof of eligibility should be submitted in sealed covers along with EMD for Rs.4000/- in the form of demand draft drawn in favour of “The Director SVP NPA, Hyderabad”.

**Terms & Conditions**

- (a) The bidding firm should have the capability to **supply By-cycles within 10 days from the date of receipt of purchase order.**
- (b) Any Government Organization/undertaking should not have blacklisted/debarred/suspended the firm.
- (c) The Vendor should preferably be an entity registered in India.
- (d) The contracted bidder is liable to be imposed with a penalty @ 0.5% of the purchase order value for every week's delay. The earnest money shall also liable to be forfeited.
- (e) The Academy reserves the right to accept in part or in full, any tender or reject any tender without assigning any reasons or to cancel the tendering process and to reject all tenders at any time, without incurring any liability, whatsoever to the affected tenderer or tenderers.
- (f) The Tender Processing Committee of the Academy may require the bidders to provide physical samples and test quality of the Bi-cycle. Bidders is self responsible on his own expenditure for showing the sample before board if demanded.

- (g) The Rates quoted should be FOR-Destination i.e SVP NPA, Hyderabad.
- (h) The Tenderer shall indicate final cost of item, after taking into account all taxes, transportation charges and other incidental charges etc and also to mention the **Guaranty /warranty period of the item/** maintenance condition.
- (i) The purchase Order is also liable to be cancelled, if the quality/progress of the supply is found to be not satisfactory or if there is an inordinate delay of more than 4 weeks in completing the supply of the ordered quantity of above items.
- (j) You will also be blacklisted by the Academy in case of (i) above being invoked.

3. The Tender shall duly be enclosed with EMD (**Earnest Money Deposit**) in the form of a Demand Draft for Rs.4000/- in favour of 'THE DIRECTOR, S.V.P. NATIONAL POLICE ACADEMY, HYDERABAD.' **QUOTATION WITHOUT THE REQUISITE EMD SHALL SUMMARILY BE REJECTED.**

4. The Academy reserves the right to increase/decrease the quantities of By-cycle indicated above, as per the needs of the Academy. Further the Academy also reserves the right to reject any offer received/cancel the entire tender enquiry, without assigning any reasons.

5. No interest will be paid on Earnest Money Deposit. EMD of unsuccessful tenders will be returned in due course of time. If the quotation is accepted and the contracted firm fails to undertake the supply contract, their EMD will be forfeited without any further notice.
