## Eight Months Of Being A Police (Wo)Man

"At the outset, let me first congratulate you for becoming an IPS officer" my Uncle said to me beaming his radiant white teeth proudly. And as a rehearsed drill, I immediately showed my modesty by thanking him and reciprocating his broad grin with my humble smile. But, the punch line always probed me 'have I actually became an IPS officer or am I just fooling around with my rank?'

The not-so-chilly winter of Hyderabad (compared to Delhi) was a relief to start training at the academy, not to mention the floating stories about the agony of training, just added spice to the atmosphere. And as the carriage was moving up, the roller coaster began with the thunder and the actual agonies started. Moulding a civilian into a commando who spent half of her life looking for logic in the things she is doing, actually gave her an existential crisis when suddenly the opposite was asked to be done. They ask you to become fearless and still use fear to cajole people to follow the commands. As the months goes by, you slowly gets transformed physically, and mentally you unlock new avenues. The training first tells you that policing is an art and art cannot be taught but has to be learned, and learning comes from experiences, so either be wise to benefit from others experiences or create your own.

So whenever I come across strangers and they get to know that I am a police officer under trainee, automatically their eyes get wider and the mouth makes a big 'O', of course with a tone of appreciation. The phone calls of safety check from parents also came down when I went alone on trips, boosting the assurance that their daughter of course can take care of herself because she is a policewoman now. It's a different story that I still struggle to strip and assemble the AKM within 20 seconds, almost feel like dying at the end of 10Km run and hardly remember the sections of IPC, CrPC, etc. But this little secret need not be known to the outside world, because for them we already carry an impression of us and so they instill a confidence in us.

It is the general tendency in which the society is wired to treat women who work in male dominated domain (say police), special, as they are seen to be unconventional and daring who venture to come out of their comfort zone. But this appreciation is also a double edged sword as the distinction of 'sahab' and 'madam' becomes evident. There goes an extra effort to make sure that an 'officer' remain gender neutral and be judged objectively based on competency and merit and it should be supported by a mutual respect without misrepresenting it to be a feminist hue and cry. I think it is the responsibility of both the major and fair sex to ensure it without going into the rhetoric.

Going back to basics, there are certain reflexes and muscle confidence that gets developed within you when you face the challenge. "I nearly shouted and threatened that cab driver for cancelling my ride without any reason and leaving me in a fix in the night without feeling guilty about it. After going through so much grilling in the academy, I won't tolerate such nonsense from an idiot and had to tell who I was." My fellow batchmate narrated this incidence to me. She wanted

to avoid revealing 'who' actually she was as there are perks of being a normal civilian on occasions, but when it came to harassment she was forced to play the power card. It only made our vulnerability so evident that is faced by 50% population of the country.

Yes, being a policewoman is a matter of pride just as I take pride in donning the uniform which gives a sense of responsibility and purpose. There is always a certain level of expectation and anticipation from the third person irrespective of what your capabilities are, and it is these 8 months that showed me how you can't afford to project your weakness but glean some confidence from whatever you believe and do what is expected out of you.

It is rather ironic to be optimistic when you are expected to be a good skeptic; to be sensitive when you are being trained to use force; to be compassionate when your job is to neutralize in operations; to take responsibility when all things aren't controlled by you. In this shade of grey area, somewhere I am trying to find myself, maybe it doesn't make much sense to me now but the time has just started with unlimited opportunities and experiences.

### Visit of Dr. Sunitha Krishnan

On 22 April 2017, the 69RR batch of IPS Probationers had the honour of interacting with Dr. Sunitha Krishnan, the founder of Prajwala, who has been battling against the organized crime of sex trafficking for the last two decades. Prajwala shelters rescued women and children and is one of the largest rehabilitation homes in the country. For her efforts in this fight, Government of India has awarded her India's fourth highest civilian award, the Padma Shri, in 2016. During the talk we came to know about many other initiatives taken by her to change the societal attitude towards victims of sexual abuse. For example, she had started the #ShameTheRapistCampaign in February 2015, in which the perpetrators of such crimes were shamed on social




media. She has also forayed into film making as a tool for advocacy and has scripted 14 documentary films on issues like youth and HIV/AIDS, the latest one being Naa Bangaru Talli, which won in Best Feature Film in Telugu category at 61st National Film

#### Awards.

Being a victim of sexual abuse herself, she gave us direct access to the worldview through which such victims see the society around them, how the society victimises the victim themselves, and what could be the possible way out of this vicious cycle. She told us about the five pillars of Prevention, Protection, Rescue, Rehabilitation & Reintegration which Prajwala is using to ensure holistic victim services.

This was indeed a very thought provoking discussion and helped us understand the various



labyrinths through which the organised network of sex trafficking works and how we as a police officers can tackle this. Collaborative partnership of all stakeholders is a must, and police as an upholder of rule of law has to ensure effective rule of law to create a violence free society. Victim needs to be put in centre of all such discussions and future policy making.

## **Breath -Probationers**

Complaints about often getting breathless

Recently, we had our Model Police Station Module. On entering the MPS, I glanced at the name of late Shri Narendra Kumar ji, immortally written on the front wall of The MPS.

Immediately my mind shifted to one of the books which I was going through online "WHEN BREATH BECOMES AIR" by late Dr. Paul Kalanithi, a 37 years old Neurosurgeon who succumbed to lung cancer. It was in his last days that DR. Paul Kalanithi decided to write this book, knowing very well that it would be published only after his death.

In such simple and lucid language did Dr. Paul Kalanithi described about his Medical School days, his Medical Training and his journey from being a doctor to a patient, without any element of self pity, that it left even the likes of persons like Bill Gates in tears.

Being a doctor myself, I could appreciate the similarity between my previous as well as present profession, through these two examples.

Dr. Paul Kalanithi reached the zenith of his academic life by becoming a Neurosurgeon but succumbed to cancer even before he could contribute much more to the society. Similarly our martyr, late Shri Narendra Kumar ji, achieved his dream of becoming on IPS, by successfully clearing UPSC examination and completing the tough training but died the death of a martyr, very early in his career.

The difference between tragedy and triumph is defined by one or two millimeters. In medical practice, it may be the size or location of cancer cells or incision which in Police it may come in the form of trajectory of bullet, or of stone pelted.

Coming to a lighter note, the title of the book of Dr. Kalanithi highlighted the word 'BREATH' the dictionary meaning of it is air inhaled and exhaled in respiration. But I am sure that all my fellow IPS probationers would admit that it is not that simple a meaning.

In fact the success of the past 8 months of training has been this single word. Right from running early in the morning to running in between classes, the one thing which has troubled us the most is to manage our breaths to perform, over perform or underperform in various activities. To avoid becoming breathless.

And yet a very strange irony has emerged as a conclusion that the major highlights of our training have not been normal is regular moments, but those breaths topping Route Marches, ITBP attachment, Bungee Jumping, Rafting, Firing, Cross Country, Scuba diving etc. etc. The maxim that "Life is not measured by the number of breaths we take, but by the moments that take our breath away" suddenly starts appearing so true inside the academy. Is any probationer still complaining!

I still remember the last 10k marathon in my school wherein I boarded the bus after the initial 1km of the marathon. प्रज्ज्वला की सबसे बड़ी विशेषता यह है कि यह संस्था मात्र वेश्यावृति में फंसी हुई महिलाओं को मुक्त नहीं करती वरन् उनके पुनरूद्धार हेतु कार्यक्रम तथा आश्रय स्थल की व्यवस्था भी करती है। जब हम उनके हैदराबाद स्थित आश्रय स्थल पर गए तो हमने देखा कि वहां पर महिलाओं को आर्थिक रूप से आत्मिनर्भर बनाने हेतु रोजगारपरक प्रशिक्षण भी दिया जा रहा है। वहां हमने वेश्यावृति से मुक्त कराई गई महिलाओं के अनुभवों को भी सुना। उन महिलाओं की बातों से यह स्पष्ट कि वे महिला संबंधी मामलों में पुलिस की सकारात्मक भूमिका को चाहती हैं। वे पुलिस को एक मित्र, मार्गदर्शक के रूप में देखना चाहती हैं।

The following methodology was adopted to achieve the Course Objectives:



# Law and order should be in the concurrent list: Speaking Against the Motion

In the scheme of our Constitution, the Indian State is supposed to have a top-down model of federalism. This has been a natural result of times in which the Constitution was framed, given the propensity of secessionist tendencies around the time of independence. Even within this Union-heavy model of a federal state, public order and police was deemed to be fit for the State List of the Seventh Schedule because every State had different priorities as far as public order was concerned. Further, the role of police and its way of working had developed over a long period of time, with regional peculiarities. Hence, the makers of the Constitution thought that allowing the Union to legislate on matters of public order and police would take away the necessary discretion from each State in these subjects.

At present, the Indian state is perhaps more complex than what it was seventy odd years back. Different States have different issues of public order and internal security. The priorities of the State Governments are also varied. What impacts public order in Jammu and Kashmir may not be the same for Rajasthan. Similarly, the requirements of public order and police in Kerala may not resonate with the requirements in Manipur. Therefore, it becomes imperative to allow States the sole authority to legislate on matters of police and public order. The 'one size fits all' model for these subjects will make law making in these areas top heavy and devoid of the necessary nuance and information required in sound law making.

It ought to be noted at this point that having a subject in the Concurrent List of the Seventh Schedule would give the Union unparalleled powers of law making on the subjects concerned. Once a subject is in the Concurrent List, a law made by the Parliament would, ordinarily, override a State law on the same subject. Therefore, allowing law and order to be in the Concurrent List will empower the Centre to overrun a State law whenever deemed suitable. This could be especially problematic when the ruling dispensations at the Centre and a State are different or are rivals in character. Therefore, the attempt to bring law and order in the Concurrent List is a reflection of a centralizing tendency.

Our experience with moving subjects from the State List to the Concurrent List, even though with the best of intentions, has not been particularly rosy. The 42nd Amendment saw subjects being moved this way into the Concurrent List, including education and forests. Although this allowed the Centre to frame overarching laws and policies, it ended up presenting a one-size-should-fit all model, not paying enough attention to the differences in requirements and capacities of each State. Additionally, even if the Union is allowed to legislate on subjects of law and order, will the Union garner enough time to do justice to these subjects? With the kind of workload the Union has to shoulder, taking up the additional load of law and order is adventurism, and is impractical.

Concentration of power at one particular level cannot bode well for the federal nature of the Indian State. It would render the States powerless, which is against the federal set-up, which forms a part of the basic structure of the Constitution. Therefore, issues of law and order such as police and public order, which are in the State List, should continue to remain in the same list.

महान भक्तिकालिक लोक संत एवं पर्यावरण वैज्ञानिक जांभोजी का जन्म 1451 ई. में पीपासर गांव नागौर (राजस्थान) में हुआ था तथा इनका कर्म क्षेत्र मुकाम समराथल (बीकानेर) राजस्थान रहा।

जांभोजी ने निराश आम जनता के सामने 29 नियमों की एक आचार संहिता रखी जैसे हरे पेड़ों को नहीं काटना, वन्य जीव जन्तुओं की हत्या नहीं करना, नशा नहीं करना, पानी छान कर पीना इत्यादि इन 29 नियमों का पालन करने वाले बिश्नोई / विश्नोई (बीस +नौ) कहलाए।

बिश्नोई समुदाय भारतीय इतिहास में वन्य जीवों के प्रति एवं पेड़ पौधों के प्रति अपने प्रेम के कारण पूरे विश्व में प्रसिद्ध रहा है।

एक महान घटना जो विश्व में इस समुदाय को अद्वितीय बनाती है, वह है, "खेजड़ली का महान बिलदान" 1730 ई. तत्कालीन जोधपुर रियासत के राजा अभयसिंह ने अपने महल मेहरानगढ़ की मरम्मत एवं चारदीवारी निर्माण का निर्णय लिया इस हेतु चूना पत्थर / लाइम स्टोन की जरूरत पड़ी चूंकि लाइम स्टोन को जलाने के लिए लकड़ी की आवश्यकता होती है। पर्यावरण प्रेमी विश्नोई समुदाय के गांव अपनी हरियाली के लिए प्रसिद्ध थे। ऐसा ही एक गांव था खेजड़ली जो अपने खेजड़ी के वृक्षों की अधिकता के कारण प्रसिद्ध था। राजा को जब यह बात पता चली तो उसने अपने दीवान गिरधारी दास मंडारी को खेजड़ली गांव से लकड़ी काटकर लाने का आदेश दिया। सैनिकों ने गांव पहुंचकर पेड़ काटने शुरू कर दिए तो खेजड़ली तथा आसपास के 84 गांवों के बिश्नोई समुदाय के गांवों में यह बात आग की तरह फैल गई और सबसे पहले माँ अमृता देवी बिश्नोई एवं उनकी 3 पुत्रियों ने वृक्ष काटने का विरोध किया पर अपनी शक्ति के दंभ में चूर सैनिक रूके नहीं फलस्वरूप माँ अमृता देवी और उनकी बेटियों ने पेड़ों को "अपनी बांहों" में भर लिया और नारा दिया कि "सिर सांटे रूख रहे तो भी सस्तों जाण" "If the head is chopped off for the sake of preserving a green tree, the resulting loss of a human life is yet a cheap bargain / If we are able to save a green tree by giving up our own head in exchange of it yet it is too cheap" अर्थात् एक पेड़ की रक्षा में अपना सिर कटवा लिए जाए तो भी तैयार रहना चाहिए।

सैनिकों ने निर्दयता से पेड़ों को बाहों में भरी माँ अमृता देवी एवं उनकी बेटियों पर कुल्हाड़ी से वार किए। वे पेड़ों से साथ ही कट गई देखते ही देखते विश्नोई समुदाय के 363 लोगों ने इस तरह से पेड़ों से चिपक कर अपने प्राणों की आहुति दे दी। जब यह बात राजा अभयिसंह तक पहुंची तो तुरंत वह खेजड़ली गांव पहुंचा। उसने बिश्नोई समुदाय से माफी मांगी तथा ताम्रपत्र पर आदेश दिया कि आगे से बिश्नोई समुदाय के गांवों में वृक्ष नहीं काटे जाएंगे एवं वन्य जीव जंतुओं का शिकार नहीं किया जाएगा। खेजड़ली के इस बिलदान स्थल पर 'विश्व का एकमात्र वृक्ष मेला उन शहीदों की याद में लगता है, जिसकी सबसे बड़ी विशेषता है कि मिहलाओं द्वारा अपने पूर्वजों को श्रद्धांजिल अपने सुन्दर गहनों आभूषणों से सज—सँवर कर दी जाती है। जो एक अद्वितीय प्रथा है जब संपूर्ण विश्व आज ग्लोबल वार्मिंग एवं जलवायु परिवर्तन से परेशान है तब यह सम. दाय अपनी लगभग 575 साल पुरानी मान्यता के अनुसार पूरे विश्व के सामने एक अद्वितीय उदाहरण प्रस्तुत करता हुआ पर्यावरण के प्रति अपने समर्पण को दर्शाता है आज भी यह समुदाय पेड़ों एवं वन्य जीवों की

रक्षा के लिए तैयार खड़ा रहता है। इस समुदाय की महिलाओं को अपने बच्चों के साथ वन्य जीव जन्तुओं को स्तनपान करवाते हुए कई जगह पर देखा जा सकता है, ''यह पर्यावरण के प्रति मानव के प्रेम की पराकाष्ठा'' है आज भी वन्य जीव जन्तुओं एवं पेड़ों को बचाने के लिए इस समुदाय के लोग अपने प्राणों को उत्सर्ग करने को तैयार रहते हैं ऐसा ही एक उदाहरण निहालचंद बिश्नोई जिसे भारत सरकार ने वन्य जीवों की रक्षा के लिए प्राणोत्सर्ग करने के लिए ''शौर्य पदक'' से नवाजा गया । महान पर्यावरण प्रेमी सुंदरलाल बहुगुणा ने भी कई बार इस समुदाय को अपना सबसे बड़ा प्रेरणा स्रोत बताया है।

खेजड़ली का महान बलिदान हमें सीख देता है कि पर्यावरण रक्षा में महिलाओं की भूमिका सबसे महत्वपूर्ण है तथा पर्यावरण रक्षा के लिए केवल सरकार की योजनाएं तब तक सफल नहीं जब तक यह जनादोलन न बन जाए।
