- 1 SVP National Police Academy, Shivrampally, Hyderabad, invites sealed bids fulfilling the following minimum eligibility criteria and as per the terms & conditions for supply of Horse Ration to the Horse Stable of the Academy.
- 2 Salient features of the tender enquiry are as follows:-

It may further be noted that Linseed & Jaggery are required to be supplied in Winter Season only (i.e. from November to February).

- 3) Tender Documents Tenders are governed by Tender documents.
- 4) Tenders received without the prescribed EMD shall be rejected forthwith.
- 5) SVP NPA shall not be responsible for postal delay or any other delay in respect of submission of bid / delay in receipt of bid and such bids will be summarily rejected.

Terms and Conditions

- (a) The Academy reserves the right to accept in part or in full, any tender or reject any tender without assigning any reasons or to cancel the tendering process and to reject all tenders at any time, without incurring any liability, whatsoever to the affected tenderer or tenderers.
- (b) The rates quoted should be FOR-Destination i.e. SVPNPA, Hyderabad.
- (c) The Tenderer shall indicate final cost of each item, after taking into account all taxes, transportation charges and other incidental charges etc.
- (d) The prices quoted shall remain **firm and fixed**, till the supplies are completed and shall not be subject to variation on any account.
- (e) Quotations should be enclosed with samples for the items quoted. **Offers received without samples shall be rejected forthwith**.
- (f) Linseed Oil and Jaggery are to be fed to Horses only in winter season and hence these items are needed to be supplied from November, 2016 to February, 2017.
- (g) Earnest Money Deposit (EMD) Rs. 54,100/- in the form of DD shall be enclosed along with the tender. The DD shall be obtained in favour of The Director, SVP NPA, Hyderabad.
- (h) Further on acceptance of tender and on placing purchase order by the Academy, the priced tenderer has to deposit Performance Security @ 5 % of the purchase order value in the form of a Bank Guarantee or Fixed Deposit Receipt within 15 days from the date of the purchase order. The Performance Security should remain valid upto 31-05-2017.
- (i) The Academy reserves the right to divide the requirement by placing multiple contracts on the basis of 'L1' rates received item-wise.
- 8) No interest will be allowed on the earnest money or security deposits so remitted and no claim shall be entertained in respect of the same. It may specifically be noted that ordinarily payment will be made only after scheduled supplies as mentioned in supply order are completed and that no advance payment will be arranged.

- 9) Further if the tenderer fails to supply the required Horse Ration items as per the stipulated delivery schedule, then the supply order will stand cancelled forthwith and the security deposit shall be forfeited. In addition, the supplier will be blacklisted for a definite period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same item(s) will be awarded to the L2 tenderer based on the same documentation & processes.
- 10) If you are interested in supplying the above horse ration items to the Academy and agree to the terms and conditions indicated above, you may submit your quotation along with EMD and samples of the quoted items **without fail**, in a **sealed cover** so as to reach the undersigned on or before 1700 hrs of 15-03-2016.
- 11) The sealed cover containing Quotation and other enclosures shall be sent to the undersigned, duly superscribed as `QUOTATION FOR SUPPLY OF HORSE RATION FOR THE YEAR 2016-2017- NOT TO BE OPENED BEFORE 16-03-2016'
