2. As such, if you are interested in supplying the above chemicals on monthly basis to the Academy, you may submit your quotation subject to acceptance of the following terms and conditions :-

- (a) The rates once quoted shall remain firm and fixed and shall not be subjected to any variation during the currency of the contract for any reason whatsoever.
- (b) The quantities required shall be subjected to change in the mid of the year as per the needs of Academy.
- (c) The quantities contracted and amended from time to time shall be strictly adhered to.
- (d) The makes/brands of the items offered and accepted by the Academy shall not be subjected to change, until and unless agreed to by the competent authority of the Academy.
- (e) Failure to deliver the ordered items in time shall entail imposing of penalty as per the discretion of the competent authority of the Academy and at the rate as deemed fit.
- (f) The supplies shall be made on monthly basis as per the quantities indicated in Column (e) of the above table.

- (g) The Academy reserves the right to cancel the entire purchase order or part thereof without assigning any reasons.
- (h) If the performance is found to be not upto the mark, the security deposit is liable to be forfeited, if deemed fit.
- (j) Any Government Organization/undertaking should not have blacklisted debarred/suspended the firm.
- (k) The Vendor should preferably be an entity registered in India.
- (l) Liability to be imposed with penalty @ 1% of the work order value for every week's delay.
- (m) Liability of the work order getting cancelled, if the quality/progress of the work is found to be not satisfactory or if there is an inordinate delay of more than 4 weeks in completing the supply.
- (n) You will be blacklisted by the Academy in case of (m) above being invoked.

3. If the above terms and condition are agreeable to you, you may submit your quotation alongwith Earnest Money Deposit (EMD) amounting to **Rs.16,500/-** (Rupees Sixteen Thousand Five Hundred only), in the form of a Demand Draft, favoring **The Director, SVP National Police Academy, Hyderabad**. **Tender not accompanied by earnest money will not be considered and will be summarily rejected**

4. Further on accepting your offer and on placing purchase order, you will submit Security Deposit for amount as indicated in the purchase order, which will be about 5% of the purchase value, in the form of a Bank Guarantee/FDR drawn in favour of 'The Director, S.V.P National Police Academy, Hyderabad'.
