LIMITED TENDER ENQUIRY

Sub: Procurement of Lucerne (Green Grass - Razka) by the S.V.P. National Police Academy for feeding its Horses during the year 2018-2019 – Reg.

The Academy intends to procure Lucerne (Green grass – Razka) to meet the feed requirements of its Horses for a period of 01 (One) Year from 01.04.2018 to 31.3.2019. About **288 kgs.** of Lucerne (Razka) is required to be supplied **daily** between 0800 am to 1000 am to the Academy Stables. The quantity will be increased or decreased by the Academy, if necessary, as per the occasion demands. **Further, in case of shortfall in supply quantity, the deficit shall be adjusted by the supplier by supplying equal quantity of good quality carrot.** The Lucerne supplied should be best quality and substandard products will not be accepted by the Academy.

2. Parties interested in supplying Lucerne to the Academy, subject to the acceptance of the above condition, may submit their quotation in the proforma enclosed duly indicating the **cost per kg** of Lucerne, in a sealed cover, so as **to reach the undersigned on or before 15 Mar 2018 at 1700 Hrs.** The sealed cover shall be super-scribed **“QUOTATION FOR SUPPLY OF LUCERNE – NOT TO BE OPENED BEFORE 16 Mar 2018.**

3. The quotation should accompany earnest money deposit of **Rs. 19,500/- (Rupees Nineteen thousand five hundred only) in the form of demand draft drawn in favour of ‘The Director, SVPNPA, Hyderabad’.** The lowest tenderer should furnish within 15 days of receipt of supply order, a Security Deposit equal to 5% of the value of the contract in the form of a FDR/Bank Guarantee drawn in favour of ‘The Director, SVPNPA, Hyderabad’, which should remain valid upto 31.05.2019.

4. No interest will be allowed on the earnest money or security deposits so remitted and no claim shall be entertained in respect of the same. It may specifically be noted that ordinarily payment will be made only after full supplies are completed as per orders and that no advance payment can be arranged.

5. If the tenderer fails to supply Lucerne within stipulated delivery period/time then the supply order will stand cancelled and the security deposit shall be forfeited. In addition, the tenderer may be blacklisted for a definite period to be decided by SVP NPA, during which no supply order would be given to the blacklisted tenderer. In this case, order for the same product(s) will be awarded to the L2 tenderer based on the same documentation & processes.
