

**CONSTITUTION AND FUNCTIONS  
OF  
SARDAR VALLABHBHAI PATEL NATIONAL  
POLICE ACADEMY BOARD**

On the recommendations of the Estimates Committee of Parliament, which visited the Academy in the early 1976, the Government of India, decided to constitute the Sardar Vallabhbhai Patel National Police Academy Board, with Union Home Secretary as Chairman and senior public servants, eminent educationists and experts on public and police administration as members.

Accordingly, the M.H.A. vide Office Order No.1/28/76--Trg./BPR&D (9) dated 20<sup>th</sup> May, 1976 constituted the Sardar Vallabhbhai Patel National Police Academy Board with the following functions:

The Board will pay visits to the SVP NPA, Hyderabad at least once during the calendar year, as may be arranged in consultation with the Director of the Academy for undertaking an annual stocktaking of the work of the Academy and making recommendations to the Ministry of Home Affairs for improving the training of I.P.S. officers in all its aspects. The functions of the Board will, *inter--alia*, be as follows:

- (1) To review every three years the syllabi of the various courses conducted at the SVP NPA so as to reflect the current needs of training in the light of the changed socio--economic milieu.
- (2) To examine the adequacy or otherwise of the educative material available at the Academy for teaching different topics of the syllabi of the courses, and to suggest ways and means for bringing about improvements or undertaking production of the material.
- (3) To suggest improvements in the methodology of training and in the use of training aids.
- (4) To examine the list of guest speakers / visiting professors and make suggestions.
- (5) To examine the quality and caliber of the directing staff and suggest ways and means of improvement, if any, including improvement in their terms and conditions of service and study tours, or courses which they should attend in India or abroad.
- (6) To examine the adequacy or otherwise of the instructional and other supporting staff at the Academy and make suitable recommendations.
- (7) To make recommendations for improvement in the physical facilities available at the Academy.
- (8) To examine the system of evaluation and suggest improvements, if any.
- (9) To make recommendations on any other matter which has a relevance to the effectiveness of training.

The life of the Board was for a period of 3 years after which its composition was to be reviewed. The Ministry of Home Affairs has, therefore, been issuing orders reconstituting the Academy Board whenever the term expires.

The existing reconstitution of the Academy Board was notified by the Ministry of Home Affairs vide their Office Order No.23011/99/2014-PT dated 09.09.2025. As per the reconstitution, the following are at present the Members of the Board.

The term of the above reconstituted Academy Board is for a period of 3 years or till re-constitution of the Board, whichever is earlier. However the members at Sl. Nos.8, 9, 10, 11 and 12 will be replaced by DGsP of other States / CAPFs on completion of term of one year with the approval of the Union Home Secretary.

## **RESEARCH FELLOWSHIP AT SVPNPA**

Aspiring candidates for the fellowship will be required to make a presentation on the research proposal before the 'Selection Committee'. The committee shall examine the proposed Research Project and also fix the duration for completion of research work.

As per the recommendations of 'Selection Committee' the candidates will be required to amend the proposal in tandem with the NPA coordinator nominated/approved by NPA.

#### **External members :**

- DG/Director (Research), BPR&D.

- Eminent Professor from University or Training Institution.

### **Eligibility & Research team structure :**

#### **I) Police Officers :**

- a) Serving: Police Officers with minimum 10 years of service with 3 years of field experience.
- b) Retired: Police Officers who retired from the service in the rank of DIG and above.

#### **II) Academicians :**

Associate Professor / Professor level Academics from the areas of Psychology, Public Administration, Sociology, Criminology, History, Philosophy, Anthropology, Political Science, Training Methodology, Information & Communication Technology, Forensic Science, Forensic Medicine, Education and similar disciplines with research experience.

**III) NPA Faculty :** Same criteria as depicted in I (a) above.

**IV) Expert Practitioner/Trainer :** With sufficient experience of imparting training in the relevant field. For quality output, the research studies pertaining to the fellowship scheme of the Academy will be undertaken by the teams rather than the individuals.

#### **Duration :**

The Duration of the Fellowship shall not ordinarily exceed one year. However, the period may be extended, where circumstances so demand, with the approval of NPA.

#### **Fellowship Amount :**

The amount of the Fellowship grant will be decided by the Director NPA on case to case basis.
