Sub: **Basic Course Phase-II Training for IPS Probationers of 77 RR at the Academy from 22<sup>nd</sup> June 2026 to 21<sup>st</sup> August 2026.**

### **JOINING INSTRUCTIONS**

The Phase-II training of Basic Course for IPS probationers of 77 RR, **who have completed all the components** of District Practical Training (DPT) as per the Compendium of Instructions, is scheduled to be held at the Academy from 22<sup>nd</sup> June 2026 to 21<sup>st</sup> August 2026. For the purpose, orders of the Cadre / State / PHQ are required duly mentioning that the probationers concerned have completed all the components of the DPT and hence, they are relieved for Phase-II training accordingly.

#### **Intimation of Travel Plans:**

Hence, as already mentioned in the Compendium of Instructions for DPT, the probationers of 77 RR should plan their travel to the Academy as per the schedule and communicate their travel plans (Flight / Train / Bus Number, Date, Time, Place of Arrival & whether local transport for pick up if required) to the Academy by e-mail to [basiccourse@svpnpa.gov.in](mailto:basiccourse@svpnpa.gov.in) latest by **15<sup>th</sup> June 2026**, and also through an online form which will be circulated in due course.

#### **Reporting:**

The probationers of 77 RR, who have completed all the components of District Practical Training (DPT) as per the compendium of instructions, are required to report at the Academy by **2200 hrs on 21<sup>st</sup> June 2026**. Late reporting will not be permitted under any circumstances. Any deviation will be viewed seriously and appropriate disciplinary action will be initiated.

#### **Accommodation:**

The probationers of 77 RR will be provided accommodation in the Academy campus. No probationer of 77 RR is allowed to stay outside the campus or keep his / her guests in his / her room allotted for stay during Phase-II training.

#### **Dress:**

The probationers of 77 RR are required to bring working uniform, **Review Order 'B'**, combat dress, riding uniform, swimming costume, formal civvies, buttoned-up coat / suit, black bandh gala / cream red saree (for Formal Dinner), traditional dress, track suit, jersey and PT dress. They should also be properly equipped with necessary footwear as per the dress code indicated in the Handbook. All the probationers are expected to follow the Dress Order without exception.

**Leave:**

No leave will be granted to the IPS probationers of 77 RR during the training except in cases of extreme exigencies. The leave requests will be considered as per the prevailing policy.

**Presentations on DPT Experience, Best Practices, and Submission of material for Cups & Trophies:**

As part of the training programme, each probationer of 77 RR is required to share his / her experiences in the DPT, Best Practices being implemented at their respective cadres and also submit material for cups & trophies. Hence, all the probationers of 77 RR should prepare well for these presentations and submission of material for cups & trophies during Phase-II training.

**Submission of Assignments of DPT & Feedback on DPT:**

All IPS probationers of 77 RR shall ensure completion of all components of their DPT assignments as per the Compendium of Instructions for District Practical Training of 77 RR. Failure to submit the assignments / reports will be viewed as non-completion of training.
