



Memorandum of Understanding

<u>Between</u>

Rashtriya Raksha University

and

Sardar Vallabhbhai Patel National Police Academy

Preamble

- 1. Rashtriya Raksha University (RRU): Rashtriya Raksha University is an Institution of National Importance under the Ministry of Home Affairs, Government of India. It is a pioneering National Security and Police University of India. The University is committed to identify, prepare and sustain statecraft of national, strategic and security culture through continuous enhancement and development of innovation, education, research and training cadres from the security, military and civilian society.
- 2. Sardar Vallabhbhai Patel National Police Academy (SVPNPA): SVP National Police Academy is primarily established to prepare leaders for the Indian Police, who will lead/command the force with courage, uprightness, dedication and strong sense of service to the people.
- 3. Whereas, Rashtriya Raksha University and Sardar Vallabhbhai Patel National Police Academy, are entering into an understanding to cooperate and share their resources and expertise in the areas of Academics, Research, Extension and Training Programs/Activities for mutual benefit. This MoU is based on fairness and equality and evidently, each step in the co-operative relationship would be based on mutual consent and consultation.

Article 1 Purpose

The general purpose of this MoU is to establish an enduring framework for educational relation and co-operation between the two participating institutions in order to promote academic learning, training, research and explore the possibility of joint academic programmes.

Article 2 Objectives

- 1. To participate in organizing seminars, training courses, workshops and programmes jointly and independently in the fields of common interest.
- 2. To exchange scholars and expert faculties for sharing experience and knowledge.
- 3. To facilitate visits by trainers and trainees from each institution to the other.



- 4. To exchange and access of academic publication materials, library, computer labs, information, data other research works related to common interest.
- 5. To share infrastructure and other facilities required for academic and research purposes.
- 6. Any other areas which come across in future and agreed mutually for common interest.

Article 3 Terms of Agreement

- 1. RRU and SVPNPA shall jointly identify the areas of training and research, where mutual cooperation is sought.
- 2. Both institutes shall exchange their scholars, experts, faculties and trainers as per the programme arranged by either institute.
- 3. In the event of jointly organized programmes, both institutes shall have to deicide mutually about the availabilities of conveyance, lodging-boarding and other expenses etc. well in advance.
- 4. The institute that invites the scholars/expert faculties for its academic purpose shall have to recognize the service with due honorarium and local hospitalities.
- 5. Both institutes shall demonstrate synergy of efforts as a team for smooth conduct of courses/programmes etc., and ensure direct interface with one another without involving external agency or specialists.
- 6. Both institutes shall take all reasonable steps to ensure the successful completion of the collaboration and co-operate each other in duly carrying out the obligations agreed upon.
- 7. Both institutes shall appoint a Nodal Officer for communication with each other.
- 8. Both institutes shall maintain confidentiality about any information course material, plan, discussion, strategy or any material, disclosed under the MoU shall be deemed to be confidential and shall be marked accordingly. Any information, course material or like in the public domain shall not be part of this commitment.
- 9. Any confidential information received by either institution, under, by virtue of this agreement shall be maintained in the strict confidence and trust and shall be used for the agreed purpose under this MoU only.
- 10. It is an obligation of all the stakeholders to observe rules and regulations of the respective institutes.



11. This MoU shall remain in force for unlimited duration until terminated by six months prior written notice given to one institute by the other institute.

In witness, whereof the undersigned, represented by The Vice Chancellor of Rashtriya Raksha University, Gujarat and The Director of Sardar Vallabhbhai Patel National Police Academy, Hyderabad; duly authorized thereto by their respective organizations, have signed the present Memorandum of Understanding.
