A five day Seminar on '**National Security**' for IAS, IFS, IPS, Indian Forest Service, IRS (IT), IRS (C&IT) and Officers from Defence Services / CAPFs as a part of joint training programmes for All India Service Officers & Defence Forces/CAPFs is being conducted from **June 08-12, 2026** at the SVP National Police Academy, Hyderabad. This is part of a series of Seminars being conducted, as approved by the Department of Personnel & Training, Government of India.

2. The objectives of the Seminar are:

- To enhance participants' knowledge of the multifaceted threats impacting national security and the significance of a multi-dimensional perspective of different stake holders;
