### **i) Travel Plans**

### **ii) Reception & Accommodation**

Arrangement for reception and transport at the Airport/railway station will be made by the Academy. The participants are not allowed to bring their drivers/helpers/maids/PSOs/Vehicles, etc. The Participants will also not be allowed to stay outside the campus, as the programme is strictly residential programme.

### **iii) Dress Order**

- a) 2 pair Camouflage Uniform (2 sets) along with Jungle Shoes, Anklet & Cap.
- b) Formal Civvies with Tie and Formal Shoes, etc. for Gentlemen and Saree/ Salwar Kameez/ Business suit for Ladies)
- c) PT Dress (preferably white)

Whenever “informal” dress order is specified for any function, it implies that tie need not be worn

### **iv) Discipline**

Participants are requested to observe appropriate discipline and etiquette throughout their stay at the Academy. Participants should not come to the Mess Lounge/Dining Hall in casuals (e.g., shorts, chappals, kurta pyjama etc.). They are also advised not to move around the campus in inappropriate attire or footwear Smoking is strictly prohibited in all areas of the campus.

v) **Facilities Available**

Service of the Officers' Club and laundry are available on payment basis at SVP NPA. Participants can avail themselves of medical facilities from the NPA Hospital if the need arises.

vi) **Family Members:**

Participants shall not bring/invite family members without the prior approval of the Director. For this, they shall apply through the concerned course director before commencement of the course. If any participants bring a family member without prior permission of the Director, NPA, he/she is liable to be sent back. The participant should pay the bills concerned to their family members before breakfast on the last day of the course.

**It is reiterated that no participant is permitted to bring any helpers/security aid/maid servant etc. along with them while they are coming to attend the programme/course.**

vii) **Pay and Leave**

All participants shall draw their pay and allowances from their State/Organization and no leave shall be granted during the Course time.

viii) **Climatic Conditions:**
