G.S.R......In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Sardar Vallabhbhai Patel National Police Academy, Syce Recruitment Rules, 2019, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of **Syce** in the Sardar Vallabhbhai Patel National Police Academy, Hyderabad, under the Ministry of Home Affairs, namely:-

1. Short title and commencement:

- (a) These rules may be called the Sardar Vallabhbhai Patel National Police Academy Syce Recruitment Rules, 20129
 - (b) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Number of post, classification and Level in the pay matrix** The number of post, its classification and level in the pay matrix attached thereto shall be specified in Columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, age limit, qualifications, etc** The method of recruitment, post, age-limit, qualifications and other matters relating to the said post shall be as specified in Column (5) to (13) of the said Schedule.
- 4. **Disqualification** No person;-
 - (a) Who has entered into or contracted a marriage with a person having a spouse living;

or

(b) Who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are grounds for so doing, exempt any person from the operation of this rule.

- 6. **Power to relax** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. **Saving**. Nothing in these rules shall effect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Exservicemen, the other Backward Class and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.

CHARTER OF DUTIES OF THE POST OF 'SYCE'

- 1. He will be responsible at all times for proper care of health and maintenance of the horse/horses entrusted on his charge.
- 2. He will himself carry out the grooming of the horse in his charge and immediately report to the Riding Master and Veterinary Officer in any sickness, ailment or injury found on a horse.
- 3. He will be responsible for proper care and maintenance of all the saddlery, grooming and feeding equipment, allotted for his horses.
- 4. He will also carry out the duties of another's syce with whom he is paired up, whenever the paired Syce in way on leave, sickness etc.
- 5. He will carry out special duties to best of his ability where ever he is detailed by the Riding Master from time to time. These duties may be such as stable guard duties, etc. He will be primarily responsible for the proper cleanness and sanitation of the stable/shall where his horses is/are kept.
- 6. He will also be his responsibility to water and feed his horse at the prescribed timing.
- 7. He will assist the Farrier in the shoeing of the horse.
- 8. He will be responsible for daily laying and cleaning of straw beddings of he horses.
- 9. He will be responsible to carry out the exercises of the horses during conducting class for the IPS Probationers.
- 10. Any other duties assigned by senior officers from time to time.
