A 5- day Course on “**Anti -Terror Intelligence, Investigation Operations**” scheduled to be held at the S.V.P. National Police Academy, Hyderabad form **07<sup>th</sup> – 11<sup>th</sup> September, 2026** for the officers of the rank of Deputy Superintendent of Police to Inspector General of Police.

2. **The objective of the Course is to facilitate learning in:**

- i. Enhanced Strategic Understanding of Terrorism, evolving terrorism landscape, threats, and contemporary counter-terrorism challenges.
- ii. Understanding Counter-Terrorism Policy & Strategy in different theatres.
- iii. Tactical & Operational Preparedness & to raise a Counter- Terror Force to deal effectively with Terrorist Organizations and its ecosystem.
- iv. Improved Investigative Competence of Law Enforcement Agencies.
- v. Supervision of investigation of cases, prosecution, and trial management in terrorism-related cases, important judicial pronouncements.
- vi. Legal and Institutional Proficiency, a thorough understanding of the provisions of the NIA Act, the UAPA, and the institutional framework for combating terrorism.
- vii. Enhancement of Operational Capability, skills, planning and executing counter-terrorism operations by Law Enforcement Agencies.
- viii. Identifying & dismantling terrorist networks, and applying lessons learned from significant case studies in various theatres.
- ix. **International Cooperation**, Understanding of terror financing investigations, the role of FIU, and international cooperation through Letters Rogatory (LR), Mutual Legal Assistance Treaties (MLAT), and extradition mechanisms.
- x. For better Inter-Agency Coordination, the best practices followed among ATS, STF, NIA, and other stakeholder agencies for an effective and integrated response to terrorism.
- xi. Use of technology and harnessing big data.
