A 6-week 'IPS Induction Training Course' (ITC-47<sup>th</sup>) is scheduled to be held at the Academy from 4<sup>th</sup> August, 2025 to 12<sup>th</sup> September, 2025. The Course is meant for the State Police Service (SPS) Officers inducted into the Indian Police Service (IPS) and who have not attended the Induction Training Course at this Academy in the past.

- 02. As per the Ministry of Home Affairs, Government of India Fax Message No.1-18012/3/2002-IPS dated 17.04.2002, completion of IPS Induction Training Course at Sardar Vallabhbhai Patel National Police Academy, Hyderabad is a compulsory precondition for confirmation of State Police Service Officers in the IPS.
- 03. The objectives of the course are to enable the participants:
  - (i) To acquire an all-India perspective,
  - (ii) To equip them with knowledge and skills required to manage a district charge, and
  - (iii) To enable them to develop an understanding of modern management principles as applied to police working.
- 04. - 05. <u>Eligibility</u>: IPS officers inducted from State Police Service (SPS) (including those working on deputation in CPOs and who have not attended the 'Induction Training Course' at this Academy in the past are eligible for the 47<sup>th</sup> ITC. It may

also be noted that officers who have less than 4 years of service, as on date of notification of MHA order appointing the officer to IPS, not eligible for the 47<sup>th</sup> ITC.

- 06. <u>Nominations</u>: It is requested to nominate eligible State Police Service (SPS) officers inducted into IPS, of the rank of SP & above to attend the proposed Induction Training Course. There is no bar on total number of nominations from any State / Cadre. Final acceptance of nominations will be done by the Academy and confirmation of acceptance of nominations will be conveyed to respective State/UTs/CAPFs/CPOs. <u>It is requested to ensure that nominated officers are medically fit to undergo the entire course</u>.
- O7. Nominations for 47<sup>th</sup> ITC may be sent in the format enclosed as Annexure 'A' along with a copy of MHA order (induction into IPS) & a copy of the undertaking certificate as Annexure-'B' from the concerned officer that he has not attend either ITC in the past at this Academy. States where government permissions is required to send nominations, it is requested to send an advance copy to SVP National Police Academy, Hyderabad to complete required formalities, well in advance. However, the nominations will be accepted subject to the clearance / No objection from the concerned Government of State / UT. In such cases, the participants are to be sent for attending the subject course only on receipt of the clearance/no objection from the concerned.
- 08. Only those officers who have no disciplinary / criminal proceedings pending against them may be nominated for the course and the States / Organizations are requested to certify to this effect while forwarding their nominations.
- 09. Detailed joining instructions will be issued to the participants, once the nominations are accepted by this Academy.
- 10. The nominated officers may please be advised to proceed for the course only after receiving confirmation of acceptance of their nominations from the Academy.
